- A guard out on deck during breaks (suggested).
- Umbrellas on guard stands need to be taller.
- Chairs need to be looked at; see if any are fixable.
- Get rid of broken chairs.
- Sunday August 10th last day.
- Monday August 11th guard clean up.

Needs looked into:

- Condensation in women's bathroom/office.
- Wetness in bathrooms and office.
- Middle stall (No key for toilet paper).
- Sanitary boxes in women's bathrooms.
- Paper towel dispensers.
- Signs on the walls for bathrooms/Prices on counter.
- Dry erase board to post notices.
- Countertops/Plexiglass or new countertop.
- Mice issues.
- Get rid of shelves and replace with moveable shelving.
- Look into raising money for bath house.
- Two out of four showers work in women's bathrooms.
