A special meeting of the Mayor and Council of the City of Milford, Nebraska was held at the Webermeier Building in said City on the 1<sup>st</sup> day of September 1998 at 7:00 P.M. Present were: Mayor Dean Bruha; Council Members Dorothy Bockoven, Rick Fortune, Charles Rich, Steve Sauer; Attorney Robert Blevens, City Clerk J. Elaine Plessel. Notice of the meeting was given in advance thereof by publishing in the Milford Times; a designated method for giving notice, as shown by the Affidavit of publication attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MILFORD, NEBRASKA:

The governing body of the City of Milford, Nebraska hereby authorizes the municipality to increase its base of restricted funds by 1% addition to and above and beyond the allowable 2.5% increase permitted under LB 989, for its municipal budget for the fiscal year commencing October 1, 1998.

Passed and adopted by at least 75% of the governing body of said municipality on September 1, 1998.
