

CITY OF MILFORD
SPECIAL MEETING
MAY 19, 2010

A special meeting of the Mayor and Council of the City of Milford, Nebraska was held at the City Offices in said City on the 19th day of May 2010 at 5:00 pm. Present were: Mayor Dean Bruha; Council members: Jeff Baker, Rick Fortune, Jeff Heckman, Dan Kral; City Clerk Jeanne Hoggins.

Notice of the meeting was given in advance thereof by posting in three public places; a designated method for giving notice, as shown by the Certification of Posting attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

CALL TO ORDER: Mayor Bruha called the meeting to order at 5:05 p.m. Mayor Bruha publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act is available for review and is posted on the south wall of the meeting room at the City Hall Office.

Hire Library Asst. Director and part time Clerk, set wages: A motion was made by Heckman and seconded by Fortune to hire Deondra Lashley as Assistant Director at \$8.00 per hour and Shawna Frederickson as part time clerk at \$7.25 per hour. Roll call vote: Heckman yes, Fortune yes, Baker yes, Kral yes. Motion carried.

Concession Stand options: Baker pursued a youth group in town to run the stand and they couldn't come up with enough interest. Hoggins had Linda Sorenson and Darla from Dragonfly Desserts inquire about running the stand. Baker noted the only other two options would be to hire someone or set up vending machines. A motion was made by Baker and seconded by Fortune to allow Linda Sorenson and Darla to run the concession stand at 100% profit minus the pop sales. Roll call vote: Baker yes, Heckman yes, Fortune yes, Kral yes. Motion carried.

ADJOURNMENT: A motion was made by Heckman and seconded by Fortune to adjourn the meeting. Roll call vote: Heckman yes, Fortune yes, Baker yes, Kral yes. Motion carried and meeting adjourned at 5:15 pm.
