A regular meeting of the Mayor and Council of the City of Milford, Nebraska was held at the City Hall Building in said City on the 2nd day of April 2024 at 7:00 pm. CURRENT BUSINESS:

Set special meeting date to approve Webermeier Scholarship recipients. A motion was made by DeLong and seconded by Keib to move forward with scheduling April 23, 2024 @ 6:30 as the special meeting to approve Webermeier scholarships. Roll call vote: DeLong yes, Keib yes, Freeman yes, Roth yes. Motion carried.

Consider Community Betterment recommendations:

Application from Dan Schweitzer for Milford Baseball Park upgrades not to exceed \$48000.00. Batting cage, scoreboard, electrical and rubber backstops on all fields: DeLong noted good discussion at the CBC meeting. They approved the application not to exceed \$48,000.00.

Dan Schweitzer noted he has private sponsor donations for part of the scoreboards.

A motion was made by DeLong and seconded by Roth to approve the application from Dan Schweitzer for Milford baseball park upgrades not to exceed \$48,000.00 for batting cages, scoreboard, electrical and rubber backstops on all 3 fields.

Keib asked if Dan had researched any grants to support this project. He had not. Roll call vote: DeLong yes, Roth yes, Freeman yes, Keib yes. Motion carried.

Application from Camille Erb/Recreation Board to replace wooden picnic tables with new tables at ballfields not to exceed \$15,000.00. The request is for 15 new metal picnic tables. There are currently 10 tables but with the additions being made to the facility they increased the request to 15. Gary was in support of this purchase as the existing table frames are close to 50 years old. They started as fiberglass tables and the top and seats have been replaced with wood a couple times. Holes are appearing in the frame bottoms. No grants had been researched for this project. They would like to enjoy them for this ball season and hopefully they will arrive for community clean-up at the ballpark so they can be assembled.

A motion was made by DeLong and seconded by Freeman to approve the application from Cami Erb/Recreation Board to purchase new picnic tables for Welch Park ballfield not to exceed \$15,000.00. Roll call vote: DeLong yes, Freeman yes, Keib yes, Roth yes. Motion carried.

Application from Danae Plessel/Kiwanis Club for handicap accessible playground equipment at Milford Public School grounds, Elementary for \$25,000.00.

Mayor Kelley informed everyone that the city has been working on a similar project; to provide handicap accessible swings and update equipment at the Uptown Park as part of Phase II of the project.

Danae shared the Kiwanis group is focused on assisting the school with an 8 bay swing set and an additional wheelchair accessible swing. The school had already been looking into this project and had received a quote from Fry & Associates. Budgeting the entire project was a concern for the school. Kiwanis will present this project during Seward County Gives; the school has agreed to pay a portion and she was hoping to secure funding from the CBC as they cannot move forward until the funds are secure. The school's playground area is used a lot, during baseball games, soccer and even after school hours.

There are 450 students in the elementary school and 3 individuals are in a wheelchair. The playground piece they are interested in will allow 1-2 students to swing along with the occupied wheelchair. Cami Erb shared the benefit of swinging for a handicapped individual as it provides an emotional, mental and physical sensory processing release.

Mayor Kelley asked again about grant opportunities as he thought this project might fit well into a grant category. Danae was not aware of any grants but there are a couple people in the Kiwanis group that are great at grant writing. The board discussed grant possibilities to reimburse the community betterment account.

After due consideration a motion was made by Keib and seconded by DeLong to approve the application from Danae Plessel/Kiwanis Club for handicap accessible playground equipment at Milford Public School grounds, Elementary for \$25,000.00 with the understanding that if a grant is awarded those funds will come back to the Community Betterment account. Roll call vote: Keib yes, DeLong yes, Freeman yes, Roth yes. Motion carried.

ORDINANCE NO. 978

AN ORDINANCE OF THE CITY OF MILFORD, NEBRASKA, AMENDING MILFORD MUNICIPAL CODE SECTION 1-903 TO CODIFY THE ADOPTION OF A NEW RETIREMENT PLAN FOR EMPLOYEES OF THE CITY OF MILFORD, NEBRAKSA, EFFECTIVE AS OF THE DATE OF THIS ORDINANCE.

WHEREAS, Milford Municipal Code § 1-903 provides for the adoption and incorporation of the terms and conditions of the Retirement Plan for employees of the City of Milford, Nebraska (the "City"); and

WHEREAS, the City wishes to provide for the adoption and incorporation of a new Retirement Plan for City employees, to be administered through such institutions, and upon such terms and conditions, as further set forth in the Retirement Plan documents attached hereto.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MILFORD, SEWARD COUNTY, NEBRASKA, AS FOLLOWS:

Section 1: That Milford Municipal Code § 1-903 shall be amended as follows:

§ 1-903 RETIREMENT PLAN.

- (A) The Retirement Plan of the City of Milford, Nebraska attached to this Ordinance No. 978 is made a part of and incorporated by reference into this section, and said Retirement Plan is restated into this section in its entirety, effective as of April 2, 2024.
- (B) The Mayor and Clerk are hereby directed to execute necessary documents to implement said Retirement Plan.
- <u>Section 2:</u> That all Ordinances and Code provisions or portions thereof in conflict herewith are hereby repealed to that extent.
- Section 3: That this Ordinance shall be in full force and effect from and after publication as provided by law and shall be published in pamphlet form.
