CITY OF MILFORD REGULAR MEETING APRIL 7, 2020 MINUTES

A regular meeting of the Mayor and Council of the City of Milford, Nebraska was held online via Zoom, pursuant to Executive Order 20-03 issued by the Governor of the State of Nebraska in said City on the 7th day of April 2020 at 7:00 pm. Present via Zoom were: Mayor Patrick Kelley; Council members: Scott Bashore, Tony DeLong, Becky Freeman, Jason Stahl; Attorney Mark Fahlsen; Chief of Police Forrest Siebken; Maintenance Supt. Gary TeSelle and City Clerk Jeanne Hoggins.

Notice of the meeting was given in advance thereof by publishing in the Milford Times; a designated method for giving notice, as shown by the Affidavit of Publication attached to these minutes. Notice of the meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public via Zoom.

CALL TO ORDER: Mayor Kelley called the meeting to order at 7:01 pm. and publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act is available for review and is posted on the east wall in the City Hall meeting room.

REPORTS/COMMUNICATIONS: Written reports received: Rescue Report for March 2020. Milford Aging Services Commission minutes for March 17, 2020.

Mayor Kelley – Report attached to these minutes. Also reported Seward County COVID-19 testing as: 111 people tested, 7 pending and 244 quarantined. Stahl reported on supplies purchased for the Fire Dept. ex: masks, safety glasses. Discussed precautions on rescue calls. Fire Dept. Pancake Feed was postponed. Webermeier Scholarship Interviews will be held on April 27, 2020. Appreciates all the work everyone is doing regarding the COVID-19 pandemic. DeLong reported in detail what the Fire & Rescue team is doing to take precautions prior to patient care. The first step is checking for fever, if indicated additional precautions are taken. A team of fire members devoted 4 hours to stripping down 1 specific ambulance, designating it specifically to COVID-19, to the bare minimum so it can be easily disinfected. Chief Siebken and his department are also taking precautions. Contact by phone, asking people to step out of their homes and utilizing PPE on stops. They are limited on the amount of PPE's available.

Mayor Kelley reported on the original PPE's that were ordered had to be returned as they were counterfeit. Freeman - the Milford Aging Services Commission met after the building closed and Amy will be doing the deep cleaning that they had considered hiring out. Amy is delivering meals with great success. First week – 21 meals, Second week – 64 meals, not sure where her numbers are for this current week. She is taking protective measures as some contacts require are closer. People in the community are designing cards which are inserted in the meals to brighten the day. DeLong: Parks – Mayor Kelley worked with the maintenance dept. to rope off the park equipment. T. Fougeron may be returning to work soon. Denver is still working but his last day may be April 14. Frey is working but will focus on mowing. Streets -Patching Project may be delayed until June. Efforts made to prep pool may include assistance from the lifeguards. Street sweeper is de-winterized. Time commitment from the maintenance staff on a water service project. Gary is researching ways to take care of icy road conditions for next winter. Bashore Library is closed but George has posted the phone # in the window allowing people to check out books in a carry-out fashion. Pool – Gary is doing what is needed to get ready, if or when the pool opens. Some lifeguards could paint the pool due to the shortage of maintenance employees. SSCSWMA meeting was cancelled. Clerk Hoggins - Sales tax received for the month of January 2020 in the amount of \$17,419.74. NPPD lease rebate payment for the month of February 2020 received in the amount of \$16,388.40.

We may be utilizing the pool staff to assist with painting and cleaning the pool this year due to limited maintenance staff.

Consider hiring Police Officer and Setting Wage: Chief Siebken and Council member Stahl conducted 2 interviews. A motion was made by Stahl and seconded by DeLong to approve hiring Paul Childers Jr. as fulltime Police Officer with a starting wage of \$17.75 increasing as high as \$18.50 after completing Basic Officer Certification at the Academy. Roll call vote: Stahl yes, DeLong yes, Bashore yes, Freeman yes. Motion carried.

April Monthly Report

- The weeks leading up to March 10th were filled with assessing the national situation, observing the local and national news and studying our Local Emergency Operations Plan. During this week I had communicated with Senior Center Director, Amy Salistean. By the weekend of 14-15, it was clear in my mind, we needed to take action. I called, President of Council, Tony DeLong and left a detailed message I wanted to meet at some point that day with him, Police Chief Siebken, fire & rescue chiefs, Dr Henley, Superintendent Kevin Wingard, Charlie Pierce from Milford Pharmacy to discuss what we now know as the pandemic COVID-19.
 - o Councilman DeLong advised me via text that he would not be able to attend a meeting that day as he had a prior engagement out of town.
 - o I then reached out to Acting Council President, Jason Stahl to ask for his availability that day for a meeting as described. Councilman Stahl accepted and assisted in reaching out to several of the listed parties and located phone numbers for others.
 - o I contacted City Atty, David Bargen to discuss my intentions and to seek legal guidance. David advised I would be creating a Health Board quorum and would need another council person.
 - I contacted Councilwoman Becky Freeman to ask for her availability as she is the liaison over the Milford Senior Center. Given the known population this virus was most susceptible to, this was the obvious choice.
 - An emergency health board meeting was held on Sunday March 15th at 4 pm with Police Chief Siebken, Councilman Stahl, Councilwoman Freeman, Dr Henley, Superintendent Wingard, Fire Chief John Melena, Rescue Chief Troy Pickerill, First Responders Tim Stewart & Wayne Stohlman and myself. Minutes are available.
 - I stayed in constant contact with Senior Center Director Amy Salistean.
- March 16th, I issued directives in the form of what became 2 press releases, closing down public building access, suspending in-home water meter change outs, in-home building inspections, suspending rental of city space.
- March 17th, Milford Public Schools issued a statement they would be closing, historically, the City policy has been if the Schools close, the Senior Center and Library will follow.
 - o I communicated several times that day with Amy
 - o I returned a call from Councilman Bashore and discussed the Library closure and what he was working on with George Matzen.
- March 18th, I issued a statement that City Hall would be closed to the public, requesting billing be completed using the drop box or paying online.
 - I've reached out to internet providers, Future Technologies, Windstream and Bluestem Fiber. All
 companies have agreed to provide assistance in one way or another to our local community and
 we should be very thankful for their generosity.
- March 19th, I reached out to Rescue Chief, Troy Pickerill to advise that our department should be receiving a PPE shipment from Four Corners in the coming days, and to let me know if he does not receive it.
- March 20th, I signed a Local Disaster Declaration.
- March 25th, I participated in an informal meeting with members of Timber Creek Addition, NPPD,
 SCC, Olson Associates, JEO, and Councilman Bashore, Gary Teselle, and Kendall Hoggins.

- March 28th, I reached out to Rescue Chief Troy Pickerill to ensure he had received information about ordering additional PPE through a State order. He advised he did and completed the order for our department.
- April 3rd, after communicating with Gary, left a detailed message with Councilman DeLong, I issued a statement that all city playground equipment would be closed to the public.
- I have been participating on calls with Four Corners Health Department on Tuesdays and Fridays with other mayors within the Four Corners Coverage area, as well as Hospital CEOs, County Emergency Management.
- I have been participating on a Governors call with Mayors from cities of the 2nd class on Wednesdays.

Throughout the month, I have remained in close contact with our staff, local Healthcare, and our Public School leadership as it relates to COVID-19. I want to sing the praise of our staff, our Police Department, and our First Responders as they have all answered the call and have stepped up in many ways including changing the way we have done business in the past. This includes keeping themselves and others informed and safe, regardless of what else they have going on. Our City Clerk has been working past 7 and 8 o'clock at night and some weekends to ensure we are receiving the information we need. I can't say Thank You enough.

I also want to take a moment to sing praises to all of our community members. We are faced with a challenging time, the likes that very few have seen in our lifetime. Our community members have stepped up in many ways to support our local businesses, donating what they can, assembling several cruise nights, which I attended the first couple and thoroughly enjoyed. The camaraderie and strength of this community really shines in moments like these. While this is a great way for our community to get out of the house and see family and friends, I want to caution everyone from gathering/piling into vehicles that are not within your direct household. I want to continue to encourage the social distancing, that we may limit the spread in our area and not put an overwhelming strain on our medical staff and facilities. Thank you All.
