**REPORTS OF OFFICERS, BOARDS AND COMMITTEES:** Written reports received were Planning & Zoning minutes for March 21, 2000; Swimming Pool Board minutes for March 22, 2000; Fire/Rescue minutes for February 8, 2000 and February 17, 2000; Police Dept. Activity Report for March 2000.

<u>Cooper</u> - Maintenance Dept. has completed blading and gravel work on alleys between 1<sup>st</sup> St. and 5<sup>th</sup> St. <u>Burroughs</u> - received applications for Pool Manager and Asst. Manager but are in desperate need of lifeguard applicants. Pool Board will be meeting on Saturday, April 8, 2000. Progress is being made on the ball field lights.

<u>Siebken</u> - Police Dept. has increased their calls of service over the last 3 months. The following policies have been activated: Domestic Violence, Arrest & Booking and Protection Orders. Block Grant monies have been received and a new computer has been purchased with these funds.

COMMUNICATIONS: Sales tax received for the month of January 2000 was \$12,723.34. Bruha - Follow up letter from Steve McMaster on the Flood Plain Study. Galaxy Cable will be introducing ISP to Milford to speed up Internet service. Seward County Economic Development Committee met on 3/28 and expressed benefit with the entire County working together. Consideration to hire a County wide manager was discussed. Next meeting date 4/25/00. Bruha has been approached by citizens concerned with the use of Engine Brakes in town. Bruha also approached by an individual to place a 250 gallon tank of propane in residential area for use of gas fireplace in an all electric home. Council to consider both items as possible addition or change to code book.

**PUBLIC HEARING: Citizen Advisory Committee** Mayor Bruha opened the Public Hearing at 7:41 P.M. Chairman Dave Whitney presented Council with a financial report of the Economic Development Committee. Noting expenses of \$2,866.00 and a balance of \$10,134.00 to date. The group is actively pursuing businesses to locate in Milford. There were no further comments. Public Hearing closed at 7:44 P.M.

## **NEW BUSINESS:**

Close Streets-Family Fun Days, Carnival – Tammy Wissing: Request was made by Chamber to block off 1<sup>st</sup> St. from "B" to Walnut for the

carnival and "B" St. from 1<sup>st</sup> to 4<sup>th</sup> for other activities to keep all activities together for Fun Days. (See attached map) "C" Street will be left open for Fire/Rescue Emergency Route. Carnival will start setting up Thursday at 5:00 P.M. and will take down by Sunday evening. A motion was made by Bockoven and seconded by Cooper to allow 1<sup>st</sup> St. from "B" to Walnut and "B" St. from 1<sup>st</sup> to 4<sup>th</sup> to be blocked off for the Family Fun Days. Roll call vote: Bockoven yes, Cooper yes, Burroughs yes. Motion carried.

Request for Variance-Habitat for Humanity Home: Bob Ficke noted that Lot 1, Block 9, of Original Town (S.W. corner of 3<sup>rd</sup> & Walnut) had been purchased to place the 2<sup>nd</sup> Habitat for Humanity Home in Milford. Plans to break ground are scheduled for May 2<sup>nd</sup>. Their wishes are to face the house towards Walnut Street. Request was made for a variance for a 17' setback in front and a 7' setback in the back. This would allow the future homeowner to place a garage on the south side of the house. A motion was made by Cooper and seconded by Bockoven to approve the variance and allow the house to be placed on the lot as per request. Roll call vote: Cooper yes, Bockoven yes, Burroughs yes. Motion carried.

Vacate Street-Maple St., South of Hwy: Dave Whitney spoke on behalf of his brother Mike to ask Council if they would consider vacating the area directly east of Mike's property leaving 20' in the rear for alley access. Mike has always maintained this area by mowing. Burroughs asked about easement of water line. It was mentioned that a sanitary sewer line may run through the property. The location was not definite. Council felt that more information needed to be obtained on location of sewer line before a decision was made.

**Approve Private Well Permits:** Fees have been paid for the following private water wells: Jim Stutzman-465 N. "F", Johnnie Walter-117 S. "F", Rick Bell-905 Park Ave., Mary Hershberger-303 N. "F", Robert Hoffman-1009 1<sup>st</sup> St. A motion was made by Bockoven and seconded by Burroughs to approve the renewal of private water well permits. Roll call vote: Bockoven yes, Burroughs yes, Cooper yes. Motion carried.

Hire Part-time Summer Maint. Help: Recommendation to hire Bryce Roth, Marcus Siebken and Billy Sauer was made by Mark Frey, Maint. Supt. A motion was made by Bockoven and seconded by Burroughs to approve recommendation of Maint. Supt. Mark Frey. Roll call vote: Bockoven yes, Burroughs yes, Cooper yes. Motion carried.

Hire Pool Employees: No action taken

**Introduction and Adoption of Resolution-Sale of City Equipment:** Discussion was held as how to sell the items. Councilmember Burroughs introduced the following resolution:

**Fire Dept. Membership:** A motion was made by Bockoven and seconded by Cooper to approve the Fire Dept. membership roster. Roll call vote: Bockoven yes, Cooper yes, Burroughs yes. Motion carried.

Introduction and Adoption of Ordinance-Amend penalty section: Councilmember Bockoven introduced the following Ordinance:

AN ORDINANCE TO REPEAL CHAPTER1, ARTICLE 11, SECTION 1101; CHAPTER 2, ARTICLE 3, SECTION 301; CHAPTER 3, ARTICLE 10, SECTION 1101; CHAPTER 4, ARTICLE 4, SECTION 401; CHAPTER 5, ARTICLE 6, SECTION 601; CHAPTER 6, ARTICLE 4, SECTION 401; CHAPTER 7, ARTICLE 5, SECTION 501; CHAPTER 8, ARTICLE 5, SECTION 501; CHAPTER 9, ARTICLE 7, SECTION 701;

CHAPTER 10, ARTICLE 7, SECTION 701 AND ADOPT A NEW PENALTY PROVISION, CHAPTER 12, ARTICLE 1, SECTION 101 TO PROVIDE A PENALTY OF \$500.00 FOR VIOLATION OF THE PROVISIONS OF CHAPTER 1, CHAPTER 2, SHAPTER 3, CHAPTER 4, CHAPTER 5, CHAPTER 6, CHAPTER 7, CHAPTER 8, CHAPTER 9, CHAPTER 10, TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH, AND TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. (See Ordinance Record)

One Way alley – between "B" & "C" and 1<sup>st</sup> and 2<sup>nd</sup>: Farmers and Merchants Bank would like to place a drive thru ATM machine in the alley behind the Bank. In order to utilize the machine they are requesting a One Way access of the alley in an easterly direction. Mayor Bruha noted that a site plan of alley and location of ATM would be helpful. Discussion was held as to continuing the asphalt completely thru the alley. A motion was made by Bockoven and seconded by Cooper to introduce and adopt the following resolution:

## **RESOLUTION NO. 364**

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MILFORD, NEBRASKA:

WHEREAS, the alley between "B" & "C" and 1<sup>st</sup> and 2<sup>nd</sup> Streets in the City of Milford, NE shall be one-way in an easterly direction and the City shall install appropriate one-way signs.

**Elevator Contract – O'Keefe:** Cooper met with Bret Ables from Omaha in regards to the maintenance of the Sr. Center elevator. A maintenance program was discussed in the amount of \$90.00 a quarter for monthly inspections, adjustments and lubrication. The annual pressure test needed for State Certification would be a separate yearly expense of \$150.00 to \$200.00. If was noted that the elevator is not used enough to warrant the maintenance program but to have the pressure test completed. The elevator at the Sr. Center is a roped hydraulic model and the State requires testing of this every 5 years at a cost of \$600 to \$700. A motion was made by Burroughs and seconded by Cooper to allow the pressure test to be

completed by O'Keefe. Roll call vote: Burroughs yes, Cooper yes, Bockoven yes. Motion carried.

**Financing** – **Ball field lights:** Burroughs presented Council with 4 options of financing and after discussion it was decided to check with the accountant and see if it was feasible to re-open the budget and pay for lights immediately. A motion was made by Burroughs and seconded by Cooper to re-open the budget and allocate the funds necessary to pay for project in full if accountant fees are reasonable. Roll call vote: Burroughs yes, Cooper yes, Bockoven yes. Motion carried.

**Executive Session:** No action taken

**ADJOURNMENT:** A motion was made by Bockoven and seconded by Cooper to adjourn the meeting. Roll call vote: Bockoven yes, Cooper yes, Burroughs yes. Motion carried and meeting adjourned at 8:56.
