# CITY OF MILFORD REGULAR MEETING AUGUST 1, 2000 MINUTES

**REPORTS OF OFFICERS, BOARDS AND COMMITTEES:** Written reports received were Milford Aging Services Commission minutes for June 28, 2000; Library Board Minutes for July 20, 2000; Fire/Rescue minutes for June 13, 2000; Police Dept. Activity Report for July 2000.

Cooper updated the Council on the State Street Project: They have finished pouring the concrete and the dirt work is almost complete. N.P.P.D is staking for poles, should have them in within 2 weeks. Northern Irrigation will begin installation of the sprinkler system on August 7, 2000. Project breakdown information was presented to Council. It was noted that item #26 (Place Sod) and all but \$242.72 of item #27 (Seeding) is being pulled from the project total. The college has agreed to pick up the cost of the sod, which would allow them to sod the majority of the area for only \$1500.00, a savings of \$357.05. #28 (Striping for Cross Walks) will also be pulled as the College and City will work together to do their own striping. Paint and materials for striping will cost around \$140.00.

Curb & gutter repair in front of Schlegel's Grocery Store is underway. The west side will be completed in 2 phases which will allow parking for patrons.

M.E. Collins will begin making repairs to the streets, in approximately 2 weeks, at 3 different locations in town. (1<sup>st</sup> & Walnut, Locust St. and 1<sup>st</sup> & "A")

<u>Burroughs:</u> The pool will be closing August 13, 2000 due to lifeguards and managers leaving for the start of school and sport practices.

<u>Fortune</u> informed Council of a letter received from the State of NE regarding inspection of the Lagoon on July 19, 2000. The overall appearance of the facility was well operated and maintained. There was water on the floor of the lift station which was coming in through a wall. The State suggested repairs to correct the problem.

**COMMUNICATIONS:** Sales tax received for the month of May 2000 was \$14,141.39. <u>Siebken</u> reviewed totals of July's Activity Report and noted that the new officer, Chad Craghead was doing a fine job. <u>Mayor Bruha</u> read resignation letters from Planning & Zoning Board members; Glenn Pasho, Howard Reidl and Paul Carter. <u>Bockoven</u> informed Council that Wells Fargo & Co. has acquired National Bank of Commerce, which holds the funds donated by William Webermeier for the Scholarships. A signature is required by the City for approval of fee arrangements between NBC and Wells Fargo Funds. <u>Bockoven</u> was also approached about creating a resolution honoring Howard Wurst for the beautification of the right-ofways at 1<sup>st</sup> St. and Hwy 6. A special meeting of the Council will be held on August 17, 2000 at 5:00 p.m. to discuss employee evaluations.

#### **NEW BUSINESS:**

City Investments: Jim Chambers with Dain Rauscher presented information to the Council regarding investing of municipal funds. He suggested using a time tested Bond Ladder of FDIC Insured CD's. A bond ladder is a portfolio of bonds with staggered maturities. Auditors encourage this way of investing because of its accuracy. Literature and documents were presented to illustrate how the ladder works. Idle funds are held in a Government Money Market that is totally liquid. Mr. Chambers suggested writing an Investment Policy for the City of Milford.

Introduction and Adoption of Ordinance – Egress Window/Setbacks: Building Inspector Roger Kness noted his concern with the fact that the egress windows are to close at the duplexes located on Thornridge Acres Dr. Fortune commented that a variance was granted to allow them to be so close. The Planning & Zoning had requested an addition to the comprehensive plan for egress window setbacks. Fortune felt the setbacks that are currently in place are adequate for the rest of the City. The issue on Thornridge Acre Dr. is private due to the fact that it is a planned development area. Cooper commented that the addition of the ordinance would not make an individual decrease the size of home but to relocate the egress window. Discussion was held as to how other towns are currently handling egress windows. Other communities do not make it a requirement but a recommendation. The Uniform Building Code requires an egress window for any basement bedroom as does the City of Milford. It was suggested that this ordinance would pertain to new construction only and existing homes in need of an egress window would be handled on a individual bases. Burroughs placed the question, with the standard 8' side yard setback that is currently in R1 zoning district and leaving 16' between homes, does the egress window need to be considered part of the structure. If 3' egress windows were adjacent to each other it would still leave 10' between homes. It was asked if the eves were considered part of the structure, as with new homes they can possibly extend 3' out just as the egress window. Further discussion was held as to whether the ordinance should specify a difference between R1 and R2 setbacks for egress windows. Blevens reviewed and revised the verbiage of the ordinance which was presented to the Council. Fortune asked if there was a plan in place as to how long the egress windows should be. Hoggins stated that there was a plan at City Hall. Kness explained the dimension and height requirements for an egress window.

Council member Burroughs introduced the following ordinance:

## ORDINANCE NO. 705

AN ORDINANCE TO ADD SECTION 4.17 TO THE MUNICIPAL CODE ENTITLED EGRESS WINDOWS; TO PREVENT ENCROACHMENT OF EGRESS WINDOWS INTO EASEMENT AREAS; TO PREVENT ENCROACHMENT OF EGRESS WINDOWS WITHIN 5' OF RESIDENTIAL SIDE YARD AND/OR REAR YARD LOT LINES; AND TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. (See Ordinance Record)

**Approve Payment-Olsson Assoc., State Street Paving:** A motion was made by Cooper and seconded by Bockoven to approve payment of Invoice No. 42975 in the amount of \$9,233.00 for professional services rendered to Olsson Associates through June 30, 2000. Roll call vote: Cooper yes, Bockoven yes, Burroughs yes, Fortune yes. Motion carried.

**Approve Initial Order- Webermeier Scholarships:** A motion was made by Bockoven and seconded by Burroughs to approve initial order of scholarships to 29 students in the amount of \$1,034.00 for the 1<sup>st</sup> Semester. Roll call vote: Bockoven yes, Burroughs yes, Cooper yes, Fortune yes. Motion carried.

**Concession Stand-High School Softball:** A motion was made by Burroughs and seconded by Cooper to allow use of the concession stand at Welch Park for sale of concessions at the High School softball games and to work closely with Fougerons. Roll call vote: Burroughs yes, Cooper yes, Bockoven yes, Fortune yes. Motion carried.

**Authorize purchase of Tar Kettle:** Cooper presented a quote from Logan Contractors Supply, Inc. for an EZ Pour 100 gallon tar kettle in the amount of \$15,925.00. The maintenance dept. is currently working with a 1970 model, which they have to combine 2 mixtures of materials and heat to get the correct consistency for pouring. The new model will heat faster and uses a 24 lb. keg of tar which is dropped into the pit. Burroughs asked about trade –in value of the old unit. Cooper suggested the possibility of selling the

old unit. Tarring street cracks is an important part of maintaining the streets. A motion was made by Cooper and seconded by Fortune to authorize purchase of a tar kettle, E-Z Pour 100P model in the amount of \$15,925.00. Roll call vote: Cooper yes, Fortune yes, Bockoven yes, Burroughs yes. Motion carried.

**Authorize purchase of Floor Jack:** A motion was made by Fortune and seconded by Burroughs to authorize purchase of a hydraulic floor jack in the amount of \$1500.00. Roll call vote: Fortune yes, Burroughs yes, Bockoven yes, Cooper yes. Motion carried.

Close 1<sup>st</sup> St. between "B" & "C" – Fire Dept.: Burroughs asked the Council for permission to close 1<sup>st</sup> St. on Friday, August 18, 2000 from 8:00 p.m. to 10:00 p.m. in conjunction with the Family Fun Days. The Milford Vol. Fire Dept. along with N.P.P.D. will be presenting a Fire & Ice demonstration involving a liquid propane burn. Chief of Police Siebken will work closely with Fire Dept. to close off the area for public safety. A motion was made by Cooper and seconded by Fortune to approve closing 1<sup>st</sup> St. between "B" & "C" on Friday, August 18, 2000 between the hours of 8:00 p.m. and 10:00 p.m. Roll call vote: Cooper yes, Fortune yes, Bockoven yes, Burroughs yes. Motion carried.

**Authorize payment, Kirkham Michael, Flood Mitigation Plan:** It was mentioned that these funds will be reimbursed to the City. A motion was made by Fortune and seconded by Cooper to authorize payment to Kirkham Michael in the amount of \$3,340.00 for professional engineering services in conjunction with the flood mitigation study. Roll call vote: Fortune yes, Cooper yes, Bockoven yes, Burroughs yes. Motion carried.

**Executive Session – Personnel:** No action taken.

**ADJOURNMENT:** A motion was made by Fortune and seconded by Bockoven to adjourn the meeting. Roll call vote: Fortune yes, Bockoven yes, Burroughs yes, Cooper yes. Motion carried and meeting adjourned at 9:08 P.M.
