REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Planning & Zoning Commission minutes for July 14, 2005; Library Board minutes from May 19, 2005; Milford Aging Services Commission minutes from July 19, 2005. Bruha – street repairs are being made and sidewalk repair at the south entrance of the Sr. Center has been completed. Bruha noted concern with water drainage/ice across the sidewalk since the drain had been removed. Good visited with Frey regarding ice melt used on new concrete. Frey commented that the product they use will not harm new concrete. Wayne Stohlman arrived. Good – Sr. Center had items to be cleaned up prior to Fun Days. Items have been taken care of. Stohlman - working on purchasing a new radio and encoder to turn sirens on at the Milford Fire Station. Mayor Plessel noted that the NARSIS report and the Fire Report for July had been presented by the Fire Dept.

COMMUNICATIONS: *Sales tax received for the month of May 2005 was \$11,105.68.

Seward County Economic Development presentation: Mark Kolterman informed the Council that a group of people have been working together for over a year towards designing the County Economic Development project. A booklet was presented laying out the plans and proposals for the committee. (Booklet included with these minutes) The idea of hiring a professional executive director to support the county and work with the Board of Directors will be strongly considered. Greg Dunlap arrived. Kolterman stated the spirit of cooperation is the key to organizing this work in progress. The Interlocal agreement will need to be fine tuned before it is presented to the communities for final approval. Milford's participation with funding will be \$4,500.00. A motion was made by Neal and seconded by Bruha to approve the concept of participation with the Seward County Unified Economic Development Group. Roll call vote: Neal yes, Bruha yes, Fortune yes, Good yes. Kolterman asked for an individual from the Council to sit on the Board of Directors. Lyle Neal nominated Dean Bruha. motion was made by Neal and seconded by Fortune to appoint Dean Bruha to the Board of Directors. Roll call vote: Neal yes, Fortune yes, Bruha abstain, Good yes. Motion carried.

NEW BUSINESS:

Introduction and Adoption of Ordinance – Separate Curb Stop per living unit: Blevens presented an ordinance and after some discussion it was decided to add to the ordinance and revise what was presented. Mark Frey arrived.

Bruha questioned giving the property owner a choice to have only one shut off and pay for the water and sewer bill. Fortune questioned if the property would be sold and the new owner didn't want to pay the utilities then we would be back in the same position we are now.

Nancy McGill with the press arrived.

Discussion was held regarding a common area inside the building where separate shut offs would be accessible to the maintenance dept. We need to avoid having the maintenance dept. enter a living unit to read meters or shut off water if necessary. It was decided to table this item.

Initial Order – Webermeier Scholarships: A motion was made by Neal and seconded by Bruha to approve 26 scholarships at \$490.40 each for the 1st semester of the 2005-2006 school year. Roll call vote: Neal yes, Bruha yes, Fortune yes, Good yes. Motion carried.

E911 Budget 2005-2006: The Council had some questions on the budget. Item tabled.

Introduction and Adoption of Ordinance – Term limits for Recreation **Board:** Council member Bruha introduced the following Ordinance:

ORDINANCE NO. 771

AN ORDINANCE TO AMEND ARTICLE 2, SECTION 205 TO ESTABLISH STAGGERED TERMS FOR MEMBERS OF THE RECREATION BOARD; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH AND TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FULL FORCE AND TAKE EFFECT. (See Ordinance Record)

Approve Library Job Descriptions: A motion was made by Good and seconded by Fortune to approve the Library Job Descriptions as presented. Roll call vote: Good yes, Fortune yes, Bruha yes, Neal yes. Motion carried. **Appointments:** A motion was made by Bruha and seconded by Good to approve the Mayor's recommendation to reappoint Connie Lindquist to the Cemetery Board with her term expiring May 2008. Roll call vote: Bruha

yes, Good yes, Fortune yes, Neal yes. Motion carried. **ADJOURNMENT:** A motion was made by Good and seconded by Bruha to adjourn the meeting. Roll call vote: Good yes, Bruha yes, Fortune yes, Neal yes. Motion carried and meeting adjourned at 8:05 pm.
