# CITY OF MILFORD REGULAR MEETING FEBRUARY 2, 1999 MINUTES

REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received: Notice of Housing Authority meeting for February 8, 1999 and minutes of January 11, 1999 meeting; Planning and Zoning Commission minutes of January 18, 1999. Fortune noted that the 1-year warranty inspection checklist for the lagoon had been made. Two minor matters needed to be taken care of and this has been done. Cooper advised that if the streets continue drying they will continue with the filling of the cracks. Frey advised Cooper that during the quarter break at SCC there will be 4 or 5 trees removed. There will be less traffic at this time was the reason for waiting for the break.

**COMMUNICATIONS:** The Sales Tax for the month of November received by the city was \$8,684.83. A Letter of Resignation from the Planning and Zoning Commission was received from Gerald Bond. Bruha informed Council that originally there were 7 members but P & Z requested that there be 9 members in order to make it easier to get a quorum. The search for a new member has not been successful. P & Z have now suggested that the number of members be lowered to 5. This will need to be done with an ordinance and Blevens will have one prepared for the March meeting. Cooper advised that a newsletter had been received from the Vector Control Association and Frey said that we belong to this at one time and would like to join again. The consensus of Council was to go ahead and send in the membership. Cooper showed a set of plans to the Council for their information as to finishing the water main loop around the Eicher Tech Center at Southeast Community College. They have remodeled the lower floor in Nebraska Hall to be used as dorms and need to install fire protection system. This is only an information item but College needs to know what the City will require. Fortune need that they should work with Dave Smith regarding traffic and Mark Frey regarding water main. Bruha advised that he has been working on filling the Council vacancy, but as of this time has not found anyone. Cooper has received a request from citizen to change the parking at the East end of First Street so there is no parking on both sides. It was felt that this narrows down and is dangerous. Fortune advised that this had come up before and Chief Smith said there is now much we can do as parking is a problem in that area because there is now place behind the residences where they can park. It was also noted that the street is not narrowed down but because of the curve it appears that it does.

PUBLIC HEARING 1 & 6 YEAR PLAN: Mayor Bruha declared the Public Hearing open at 7:45 p.m. Jeppson, City Street Superintendent, provided copies of information of "Distribution of Highway User Revenue" and the "Annual Reporting – Highway Allocation Funds" to all members of the Council. It was noted that they try to get to the Council every two or three years to explain the One Year and Six Year Plan. It was noted that any project on the streets over \$20,000 needs to have the Engineer's approval. Mayor Bruha welcomed comments from the public and there being none, he closed the Public Hearing at 7:54 p.m.

**NEW BUSINESS:** <u>Introduction and Adoption of Resolution to Adopt 1 & 6</u> Year Plan.

<u>Introduction and Adoption of Ordinance Pool Table Permit</u> Bockoven introduced the following ordinance:

## ORDINANCE NO. 689

AN ORDINANCE TO REPEAL ARTICLE 3, CHAPTER 3, SECTIONS 10-307 AND 10-308 OF THE MUNICIPAL CODE REGARDING POOL TABLES AND BILLIARDS REGULATIONS; AND TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. (See Ordinance Record)

Approval of Payment-Olsson Associates A motion was made by Fortune and seconded by Bockoven to approve payment to Olsson Assoc. in the amount of \$422.57 which is for preparation of As-Built Drawings, site survey for locating limits of lagoon access road and assistance during the lagoon discharge including preparation of a "discharge volume" table. Roll call vote: Fortune yes, Bockoven yes, Cooper yes. Motion carried.

<u>Bid & Specs-Dump Truck</u> Cooper advised that the specs are for a truck similar in size to the present truck, but with a heavier front suspension. The maximum weight is 26,000 pounds because if it were heavier the maintenance personnel would need a CDL license. We would be going with a diesel engine, live hydraulics, manual transmission and the sander is only an option item. A motion was made by Cooper and seconded by Fortune to approve the bid specs and authorize advertising for bids for truck. Roll call vote: Cooper yes, Fortune yes, Bockoven yes. Motion carried.

Lee Becker-EA Engineering-Water main ext. Camp Easter Seal Lee Becker with EA Engineering is retained by the Burlington Northern Santa Fee RR to evaluate the water supply for the camp. If a new supply is needed they are checking various paths so are appearing at this time for information only. It was noted that they would need a 4" and possibly a 6" line if used for fire protection. Virgil Johnson advised that decision needs to be made soon, as they will begin hiring around March 15. Time is a factor and wondered how soon City would be able to act on this. It was noted that when plan are ready, a special meeting could be called to act on this. The cost of the line extension would be covered by the railroad and the camp

<u>Executive Session-Personnel</u> A motion was made by Fortune and seconded by Cooper to go into Executive Session. Roll call vote: Fortune yes, Cooper yes, Bockoven yes. Motion carried and Council adjourned from regular session at 8:21 p.m.

A motion was made by Bockoven and seconded by Fortune to return to Regular Session. Roll call vote: Bockoven yes, Fortune yes, Cooper yes. Motion carried and Council returned to regular session at 8:55 p.m.

<u>Police Dept. Appointment</u> A motion was made by Bockoven and seconded by Cooper to authorize Chief Smith to offer the position as police officer to Scott Decoste at a staring hourly wage of \$9.75. Roll call vote: Bockoven yes, Cooper yes, Fortune yes. Motion carried.

A motion was made by Bockoven and seconded by Fortune to promote Scott Fosler to Sgt. with a \$.25 per hour wage increase. Roll call vote: Bockoven yes, Fortune yes, Cooper yes. Motion carried.

**ADJOURNMENT:** A motion was made by Bockoven and seconded by Fortune to adjourn the meeting. Roll call vote: Bockoven yes, Fortune yes, Cooper yes. Motion carried and meeting adjourned at 8:56 p.m.
