## CITY OF MILFORD REGULAR MEETING FEBRUARY 3, 2009 MINUTES

A regular meeting of the Mayor and Council of the City of Milford, Nebraska was held at the Webermeier Library Building in said City on the 3<sup>rd</sup> day of February 2009 at 7:30 pm. Present were: Mayor Dean Bruha; Council members: Jeff Baker, Rick Fortune, Jeff Heckman, Dan Kral; Attorney Robert Blevens; Chief of Police Forrest Siebken; Maintenance Supt. Mark Frey, City Clerk Jeanne Hoggins. Also present: Beverly Wehrs, Sharon Neihardt, Logan Rainforth, Bill Abts, Nancy McGill and Nancy Swarts.

Notice of the meeting was given in advance thereof by publishing in the Milford Times; a designated method for giving notice, as shown by the Affidavit of Publication attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

**CALL TO ORDER:** Mayor Bruha called the meeting to order at 7:32 p.m. Mayor Bruha publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act is available for review and is posted on the east wall of the Webermeier Community Meeting Room.

REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Housing Authority minutes for January 8, 2009; Planning & Zoning minutes for January 26, 2009; Milford Aging Services minutes for January 27, 2009; Fire Department minutes for December 9, 2008; Police Dept. Activity Report for January 2009; MVFD Rescue NARSIS report for January 2009; Fire Report for December 2008. \*Heckman met with the Library Board for the first time. A concern was noted regarding the maintenance on the heating unit and requested that a punch list be presented at the time of service to record what was looked at and the condition of the unit. We had a potentially dangerous situation, luckily everything has been repaired. Frey will visit with Milford A/C to request the punch list. \*Baker - The Sr. Center vehicle was in an accident with a BNSF truck. The truck ran into the driver side of the car. \*Chief Siebken reported on January's activity. \*Frey - the City has been experiencing brown water problems. In checking with the State it is not harmful, just a nuisance. There are 2 ways to remedy this situation: the first is too expensive, the second is to flush the system 3 to 4 times a year. Frey suspects this problem has arose because this year has been the lowest amount of water pumped in the last 10 years. Frey explained how the chemicals react to the iron, which causes the water to turn brown. \*Bruha has been monitoring the snow removal on sidewalks and if we get another big snowfall he may be issuing notices to individuals that are not complying with the snow removal ordinance. Bruha also requested the snow that is piled up in the middle of the business district be cleaned off even if it takes some additional hours of overtime.

**COMMUNICATIONS:** \*Sales tax received for the month of November 2008 was \$8,307.78. \*Thank you received from Webermeier Scholarship recipient Susanne Fiala.

**PUBLIC HEARING: One & Six Year Plan:** Bruha explained that the current one & six year road plan is basically for general maintenance and upkeep of streets. Mayor Bruha opened the public hearing at 7:47 pm and asked if there were any comments from the public. Discussion was held regarding the repair of Hwy 6 thru town. There are repairs needed on the curve which the State DOR will take care of. With no further questions the public hearing was closed at 7:50 pm.

### **UNFINISHED BUSINESS:**

**Introduction and Adoption of Ordinance – Definition of Dangerous Dog:** Blevens presented a model dog & cat ordinance for review. The Council needs to decide what they want to do. The following were areas of discussion: Providing Liability Ins., by the owner, for animals at the time they are licensed; requirement of leashes & muzzles; fines/penalties for offenses, (whether it be running at large or biting someone); banning specific breeds from town; what determines a dangerous dog? These areas were discussed at length. It was suggested that Council member Baker put together an ordinance that he is comfortable with addressing all the areas of discussion. He will work with Attorney Blevens and have an ordinance for all members to review/revise prior to the March regular meeting.

Contract/Agreement to purchase sewer manhole, clean-out and sewer **line to main:** Fortune asked the Council's permission to have the City send out for review and consideration the purchase agreement to the 2 individuals and Church. Fortune made a motion not to move on the agreements until the access agreement is signed by the Golf Course. John Melena assured Fortune that it wouldn't be a problem. Heckman asked what the dollar amount was. Fortune stated, "it is \$1900.00 each". Heckman questioned the other 2 parties wanting to be reimbursed. (Barry Stauffer and Grace Missionary Church) Fortune noted that they all want to be reimbursed. Heckman asked if they had receipts for the work done. Fortune stated, they did. Baker seconded the motion and asked for discussion. Baker asked if the City is legally bound to pay for the line? Attorney Blevens noted that it can be left as a private line. Baker didn't feel that the City should buy a sewer line that was once a private line and not in the City limits. (It's on the Golf Course) Given the circumstances with the tax revenue and the economy Baker didn't think we should be paying for something that we are not bound to purchase. Spending \$1900.00 x 3 is not a good idea. Baker questioned if the private sewer line meets the specifications as if the City would have put it in themselves. Frey noted that he worked with the contractor and used the

specs that would have been used if the City would have placed the line. Fortune noted that the City would've been responsible for putting the sewer line in after the annexation process. These individuals saved the City money by putting the line in themselves. If the City would have placed the line, an engineer would have been involved and the project would of cost a lot more. Fortune feels the City needs to own this line. It's a fairness issue and we need to own the manhole and line. Baker's thought process was if the City buys the line tomorrow and the line goes down, then the City will be spending \$20,000.00 to repair the line. Mark Frey oversaw the construction of the line and it was built by City specifications, it is a perfectly good line and manhole, "it is not going to go down" commented Fortune. The question came up if another manhole would need to be constructed if someone built a home on the empty lot. Access would need to be granted by Barry Stauffer. Fortune wants to know if the Council will back this proposal. Kral asked Fortune if he would accept an amendment stipulating the amount of money to be offered. Fortune stated, "Yes it needs to be stipulated". A motion was made by Fortune and seconded by Baker to approve payment of \$1900.00 to 3 individuals to purchase the portion of the sewer line on the Golf Course from the manhole to the City main upon agreement that Thornridge Golf Course sign the access agreement and grant an easement. Roll call vote: Fortune yes, Baker no, Heckman yes, Kral yes. Motion carried.

### **NEW BUSINESS:**

**Approve Committee List:** The 2009 Committee List was presented: There were questions regarding the Economic Development Committee members and city representative. Mayor Bruha will look into these questions and present the facts at the next regular meeting. A motion was made by Baker and seconded by Fortune to approve the 2009 committee list as presented. (Copy attached) Roll call vote: Baker yes, Fortune yes, Heckman yes, Kral yes. Motion carried.

# Introduction and Adoption of Resolution – One & Six Year Plan: RESOLUTION NO. 446

The following resolution was introduced by Kral, who moved its adoption, seconded by Fortune,

#### ORDINANCE NO. 818

AN ORDINANCE AUTHORIZING THE ISSUANCE OF REFUNDING BONDS, OF THE CITY OF MILFORD, NEBRASKA, IN THE PRINCIPAL AMOUNT OF SIX HUNDRED TEN THOUSAND DOLLARS (\$610,000) ISSUED TO REFUND CERTAIN OUTSTANDING BONDS OF THE CITY; PRESCRIBING THE FORM OF SAID BONDS; PROVIDING FOR A SINKING FUND AND FOR THE LEVY AND COLLECTION OF TAXES TO PAY SAID BONDS; PROVIDING FOR THE SALE OF THE BONDS; AUTHORIZING THE DELIVERY OF THE BONDS TO THE PURCHASER; PROVIDING FOR THE DISPOSITION OF THE BOND PROCEEDS AND ORDERING THE ORDINANCE PUBLISHED IN PAMPHLET FORM. A motion was made by Heckman and seconded by Baker to approve the Mayor's recommendation to appoint Julie Brehmer to the Pool Board for a 3 year term ending 2/1/2012. Roll call vote: Heckman yes, Baker yes, Fortune yes, Kral yes. Motion carried.

**Authorize Mayor to sign – Federal Equitable Sharing Agreement:** A motion was made by Fortune and seconded by Kral to authorize Mayor Bruha to sign the Federal Equitable Sharing Agreement presented by Chief Siebken. Roll call vote: Fortune yes, Kral yes, Baker yes, Heckman yes. Motion carried.

**Discuss temporary Sr. Center Shuttle:** On January 16, 2009 the Sr. Center Shuttle was involved in an accident with a BNSF truck. Two estimates have been gathered: Heartland Auto Body - \$2040.24 and R & H Body Shop - \$2074.40. Volunteer drivers are using their personal vehicles to deliver meals, which Baker has authorized payment of mileage (.55 per mile) for this service. BNSF has been contacted regarding a rental vehicle, but no response as of 2/3/09. The purchase of a van has been considered for ease of

meal delivery and transportation of individuals. Baker will continue to negotiate with BNSF to expedite settlement and allow the Sr. Center to purchase a different vehicle.

**ADJOURNMENT:** A motion was made by Fortune and seconded by Kral to adjourn the meeting. Roll call vote: Fortune yes, Kral yes, Baker yes, Heckman yes. Motion carried and meeting adjourned at 9:09 pm.
