REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Housing Authority minutes for December 14, 1998 meeting and notice of January 11, 1999 meeting; Planning & Zoning minutes for December 21, 1998; Milford Aging Services Commission minutes for December 16, 1998.

Sauer reported the Sr. Center Elevator punch list will be completed on January 8, 1999. Cooper advised Council of maintenance department problem with air compressor. They will be renting one for now but will draw up specifications to replace unit with next year's budget. They were able to start filling cracks in the street prior to snowfall. New street sweeper is working well. New specifications for a dump truck are also being worked on.

COMMUNICATIONS: Resignation letter from Steve Sauer was read with effective date of January 29, 1999. Accepted by the Mayor. Council will be looking for a replacement immediately.

Sales tax received for the month of October was \$10,274.09.

NEW BUSINESS: <u>Reappointment</u> -Bockoven made a motion to reappoint Dean Rhoads to the Housing Authority for a 5 year term and Sauer seconded the motion. Roll call vote: Bockoven yes, Sauer yes, Cooper yes, Fortune yes. Motion carried.

<u>Appointments</u> A motion was made by Sauer and seconded by Fortune to appoint the following people to the Milford Aging Services Commission for a 2 year term: Dr. Keith Johnson, Wilma Phelps and Mary Williams. Roll call vote: Sauer yes, Fortune yes, Bockoven yes, Cooper yes. Motion carried.

A motion was made by Fortune and seconded by Bockoven to appoint Phyllis Koch to the Library Board. Roll call vote: Fortune yes, Bockoven yes, Cooper yes, Sauer yes. Motion carried.

<u>Pool Table Permit Fees</u> A motion was made by Fortune and seconded by Sauer to repeal the pool table fee. Roll call vote: Fortune yes, Sauer yes, Bockoven yes, Cooper yes. Motion carried.

<u>Fire Station Usage Policy</u> Cooper attended the December Fire Dept. meeting and officers' meeting to discuss the rental fee for fire department personnel. After discussion it was decided to maintain the deposit for maintenance and damage. A motion was made by Sauer and seconded by Fortune that Fire personnel will be allowed to use the Fire Station at no rental fee (but subject to deposit requirements). If a reservation is made and then cancelled less than 2 weeks prior to the event, \$25.00 will be deducted from deposit and the balance returned. Roll call vote: Sauer yes, Fortune yes, Cooper yes, Bockoven yes. Motion carried.

Lagoon-Farm unused land A motion was made by Fortune and seconded by Sauer to accept the offer of \$300.00 from Clark Rediger to farm the unused land at the lagoon site. This is an annual fee and will be discussed each year. Roll call vote: Fortune yes, Sauer yes, Bockoven yes, Cooper yes. Motion carried.

<u>Review Proposed One & Six Year Plan</u> Council was presented the One & Six Year Plan and reviewed it. A motion was made by Fortune and seconded by Cooper to hold a Public Hearing for the One & Six Year Plan at the February 2, 1999 regular meeting. Roll call vote: Fortune yes, Cooper yes, Bockoven yes, Sauer yes. Motion carried.

<u>Approval Sr. Center Bldg. Use Policy</u> The policy was rewritten to mirror the form used for the Webermeier & Fire Station use policy. A motion was made by Sauer and seconded by Bockoven to approve Sr. Center use policy with usage fee at \$50.00 for regular and commercial use pending approval of Aging Services board. Roll call vote: Sauer yes, Bockoven yes, Cooper yes, Fortune yes. Motion carried.

ADJOURNMENT: A motion was made by Bockoven and seconded by Cooper to adjourn the meeting. Roll call vote: Bockoven yes, Cooper yes, Fortune yes, Sauer yes. Motion carried and meeting adjourned at 8:09 p.m.
