REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Planning & Zoning Commission minutes for June 9, 2005; Milford Aging Services Commission minutes from June 21, 2005; and Police Dept. Activity Report for June 2005. Good – Letter of resignation received from Sr. Center Board member Lewis Miller. Fortune - Fire Dept. report presented. We've had some bad test results on the wells but we will Siebken reviewed activity report for June 2005. be retesting. Homeland security grant funds will be used to purchase a radio console, which will be used with the Emergency Management for paging and activating sirens. Frey reported on the nitrate levels of wells 1 & 2 and blending with well #3 at Welch Park. The nitrate levels of wells 1 & 2 are high but when blended with well 3 meet required safety levels. Nitrate levels on well 3 jumped to an unusual high, which caused some concern. DEQ questioned the extreme jump and therefore retesting will be allowed to make sure we didn't receive a bad sample. Wayne Stohlman arrived at 7:38 pm. Discussion was held last month about drilling a deep test well. More discussion will be held regarding this matter after additional testing is completed. Water levels were discussed and Frey reported 16 to 20 hours a day are used for pumping water. It was mentioned to notify the public to cut back on watering.

COMMUNICATIONS: *Sales tax received for the month of April 2005 was \$12,156.92.

UNFINISHED BUSINESS:

Employee Handbook: Siebken presented a change stating any employee that works an actual holiday would be paid time and a half for actual hours worked plus the 8 hours of regular holiday pay. Fortune noted that after due consideration of the situation that it would be best to leave the policy as is. The employee handbook will remain as earlier approved.

Introduction and Adoption of Ordinance – Water/Sewer Disconnect: Fortune reviewed with the Council the safety concern of having the maintenance dept. enter into an apartment or living unit to shut off water for delinquent billings. Since the City has allowed dwellings to be built with only one shut off access to multiple units consideration should be taken to possibly grandfather these units since the expense to meter each unit would be very costly. Fortune asked Blevens if an ordinance could be established stating all multiple units from this point would have to have separate curb stops for each living unit. Merle David's arrived at 7:50 pm. It was suggested to inform the landlords, with a letter, explaining the City's situation on this matter. It was suggested to have a Police officer go with the maintenance dept. to insure the safety and well being of everyone involved. Blevens will present an ordinance at next months meeting regarding curb stops per living units.

Friends of the Library, 2nd Street Closing, July 18th: Nancy Jantze asked the Council's permission to close 2nd Street between "B" &"C" from 4:00 pm to 9:00 pm for the Friends of the Library Book Fair. A motion was made by Neal and seconded by Good to allow 2nd Street to be closed. Roll call vote: Neal yes, Good yes, Bruha absent, Fortune yes. Motion carried.

Set date Budget Work Night: Thursday, July 21, 2005 at 6:00 pm.

Sewer Jet – possible bid letting: A motion was made by Fortune and seconded by Neal to proceed with the bid process for a new sewer jet. Roll call vote: Fortune yes, Neal yes, Bruha absent, Good yes. Motion carried.

Appointments: A motion was made by Fortune and seconded by Good to approve the Mayor's recommendation to appoint Gene Waring to the Milford Aging Service Commission term ending January 2007. Roll call vote: Fortune yes, Good yes, Bruha absent, Neal yes. Motion carried.

A motion was made by Good and seconded by Fortune to approve the Mayor's recommendation to re-appoint Glenda Maury and Susan Trabert to the Milford Aging Services Commission for their 2nd term, ending January 2007. Roll call vote: Good yes, Fortune yes, Bruha absent, Neal yes. Motion carried.

Beer Garden – Merle David's, Fun Days: A motion was made by Fortune and seconded by Good to allow Sheri's Grill & Bar at 121 Hwy 6 to have a beer garden on August 20, 2005 from 10:00 am to 1:00 am. Roll call vote: Fortune yes, Good yes, Bruha absent, Neal yes. Motion carried.

Economic Development Aid Proposal: Dragonfly Desserts by Randy & Cheryl Brown are occupying the building at 518 1st Street. The new business entails cakes and an espresso coffee shop. The Economic Development Committee has offered a \$5,000 grant and a \$10,000 0% interest loan to be paid back in 7 ½ years beginning payment in 18 months. Fortune asked if the requirements had been met. Dragonfly Desserts will create 5 employment positions. Neal noted that the Economic Development funds are to be used as seed money to help businesses get started and yet some of the funds will be paid back. A motion was made by Neal and seconded by Good to allow the disbursement of funds to Dragonfly Desserts including a \$5,000.00 grant and a \$10,000.00 0% interest loan to be paid back in 7 ½ years starting payment in 18 months after review and approval of the contract by Attorney Blevens. Roll call vote: Neal yes, Good yes, Bruha absent, Fortune yes. Motion carried.

Circle Drive Concerns: Rick Bell presented a concern with the street at Park Ave. and "E" Streets, established as "Circle Drive". The street is a one way and is very narrow, only 18' 10". Parking is allowed on Circle Drive, which makes it more difficult to pass thru. There is also a drainage problem where water from Park Avenue, North "E" and Circle Drive meet. Snow removal is difficult and the curbing is deteriorating is areas. Bell presented 2 options to correct the problems. 1) Remove the grassy area, tree and curbing and replace with paving, creating a cul-de-sac. 2) Leave the tree and a small portion of the grassy area and widen the existing lane to standard street width. The Council agreed that an engineer will need to look at the streets to determine a solution and address the drainage issue. This will be an item to consider during budget prep. Mayor Plessel and the Council thanked Rick Bell for presenting his concern.

ADJOURNMENT: A motion was made by Fortune and seconded by Neal to adjourn the meeting. Roll call vote: Fortune yes, Neal yes, Bruha absent, Good yes. Motion carried and meeting adjourned at 8:32 pm.
