REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Planning & Zoning Commission minutes for May 12, 2005; Milford Aging Services Commission minutes from May 17, 2005; and Police Dept. Activity Report for May 2005. Bruha informed the Council of addressing parking issues at a later date. Blocking alleys and using yards as parking lots. Siebken reviewed activity report for May 2005. Yeackley presented the NARSIS report for May 2005. 13 rescue calls for May bring the yearly total to 79. 3 fire calls reported for May totaling 18 for the year. The new Fire Equipment should arrive early August. The Dept. is hoping to have it on display for Fun Days. TeSelle reported that all the ball fields look good and the ball program is up and running. The pool is also open and running well. A well went down the other day but it is now up and running. Mayor Plessel has been receiving questions about water restrictions this year. TeSelle reported no restrictions night now, water levels recovered over the winter months. Bruha noted that the intersection at 5th & "B" Street has been repaired and a section of the intersection at 4th & Walnut has been repaired.

COMMUNICATIONS: *Sales tax received for the month of March 2005 was \$15,028.95. * NPPD First Quarter 2005 lease agreement payment received in the amount of \$31,128.73. * Aquila Franchise Tax payment received for March '04 thru April '05 in the amount of \$18,163.18. * Thank you letters from Webermeier Scholarship recipients Christine Baughman and Kendra Larsen.

UNFINISHED BUSINESS:

Employee Handbook: Siebken presented the idea of paying only the officer/officers that actually works the holiday time and half for hours worked. Hoggins noted that the holiday pay for the Police Dept. would be more of a benefit for them than any other dept. The Maintenance Dept. would be paid time and a half only if a situation would arise and they would happen to get called out. The Police Dept. would be getting paid the

additional amount every holiday. Fortune arrived at 7:20 pm. The Council would like Siebken and Hoggins to write up proposals for this issue and present them at the next meeting. Neal noted that this issue needs more discussion and the agenda is quite long. A motion was made by Neal and seconded by Bruha to table the agenda item for the next regular meeting. Neal yes, Bruha yes, Fortune yes, Good yes. Motion carried.

Introduction and Adoption of Ordinance – Water/Sewer Disconnect: Fortune noted that some other issues have come up with the ability to disconnect services for non-payment. Fortune would like to have a special meeting to review the current ordinances and work out the issues that the employees are facing with the water disconnects. A motion was made by Fortune and seconded by Bruha to table item and call a special meeting to discuss water/sewer disconnects. Roll call vote: Fortune yes, Bruha yes, Good yes, Neal yes. Motion carried.

Introduction and Adoption of Ordinance- 2003 International Codes and 2003 International Energy Conservation Codes: Blevens needed more time to prepare all the paper work. Item tabled to the July meeting.

NEW BUSINESS:

Introduction and Adoption of Ordinance – Fire Equipment Bond: Council member Fortune introduced the following ordinance:

ORDINANCE NO. 763

ORDINANCE AUTHORIZING THE ISSUANCE OF FIRE EQUIPMENT BONDS OF THE CITY OF MILFORD, NEBRASKA, IN THE PRINCIPAL AMOUNT OF THREE HUNDRED THIRTY-FIVE DOLLARS (\$335,000) FOR **PURPOSE** THOUSAND THE PURCHASING FIRE TRUCKS AND OTHER FIRE-EXTINGUISHING APPARATUS FOR THE CITY; PRESCRIBING THE FORM OF SAID BONDS; PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE SAME; PROVIDING FOR THE SALE OF THE BONDS; AUTHORIZING THE DELIVERY OF THE BONDS TO PURCHASER; PROVIDING FOR THE DISPOSTION OF THE BOND PROCEEDS AND ORDERING THE ORDINANCE PUBLISHED IN PAMPHLET FORM. Street Closing – Fun Days: Rosemary Thomas presented the street closings for Fun Days. Street closing requests: "B" Street from alley between 1st & 2nd to Hwy 6 or 5th Street, 2nd St. between "B" & "C" St., 1st St. between "B" & "C" St., 3rd St. between "B" & "C" St., "C" St. between 2nd & 3rd St. from 10:00 am to 11:30 am. Discussion was held with concerns of the barricades placed directly on 5th St. It was suggested to place the barricades on "B" St. between 4th & 5th to allow for a 1 block buffer before any activity would approach the Hwy. A motion was made by Fortune and seconded by Good

to allow the street closings for the Fun Days weekend as proposed. Roll call vote: Fortune yes, Good yes, Bruha yes, Neal yes. Motion carried.

Concession Stand/Restroom Update: Due to a death in the family the presentation will be made at the July meeting.

Southeast Community College Building Presentations: SCC Instructor Karen Koch and 15 of her students presented proposed plans for a new municipal building. The presentation included 7 groups of 2 to 3 students, which presented site plans, furnished floor plans, electrical, hvac, elevations and a final cost analysis. The students work and effort was much appreciated.

Introduction and Adoption to Amend Ordinance – Abandon Handicap Stalls on State Street: Council member Neal introduced the following ordinance:

ORDINANCE NO. 764

AN ORDINANCE TO ESTABLISH OR RELOCATE HANDICAPPED PARKING STALLS TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH AND TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. (See Ordinance Record)

Introduction and Adoption of Resolution – Designate Loading Zone on State Street: A motion was made by Bruha and seconded by Fortune to adopt the following resolution. Roll call vote: Bruha yes, Fortune yes, Good yes, Neal yes. Motion carried.

RESOLUTION NO. 412

Be it resolved by the Mayor and City Council of the City of Milford, NE that:

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MILFORD, NEBRASKA:

Section 1. There shall be no parking upon State Street from State Highway #6 to the South City Limits on either side of said street, except loading zones as provided by Section 2 hereof, and handicapped parking as provided in Section 3 hereof.

Section 2. The following portions of State Street from State Highway #6 to the South City Limits are designated as loading zones.

- (a) One (1) 20' by 16' loading zone on the East Side of State Street, immediately north of the north front entrance of 600 State Street, known as the Southeast Community College Administration Building, or the "Eicher Technical Center".
- (b) One (1) 20' by 16' loading zone on the East Side of State Street, immediately south of the south front

- entrance of 600 State Street, known as the Southeast Community College Administration Building, or the "Eicher Technical Center".
- (c) One (1) 20' by 16' loading zone on the West Side of State Street located at 611 State Street, (Cornhusker Hall, Southeast Community College).
- (d) Two (2) 13' by 16" loading zones on the West Side of State Street located in front at 621 State Street, (Nebraska Hall, Southeast Community College).

Section 3. The following portion of State Street from State Highway #6 to the South City limits is designated for handicapped parking.

(a) Three (3) – 13' by 16' handicapped parking stalls located directly in front of 621 State Street, (Nebraska Hall, Southeast Community College).
