REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Housing Authority minutes for October 13, 2000; Library Board Minutes for October 19, 2000; Fire/Rescue minutes for August 8, 2000 and September 12, 2000; Police Dept. Activity Report for October 2000.

<u>Fortune</u> received a study from Olsson Assoc. on repairs to the water tower. <u>Burroughs</u> checked into fencing and netting for foul ball protection behind the ball field backstops. The proposal was over \$10,000. Burroughs will be checking into other possibilities. <u>Cooper</u> reported that most of the work had been completed in the alley's. N.P.P.D. has been working on the lights on the State Street Project. Poles will hopefully go up next week.

COMMUNICATIONS: *Sales tax received for the month of August 2000 was \$13,527.36. *SENDD Affordable Housing Annual Mtg. to be held at Table Creek Golf Course, Nebraska City, on November 16, 2000 at 5:45 p.m. *Received a letter from Chris Johnson with Kirkham Michael regarding the Flood Mitigation Plan. Information has been gathered from the field survey at Camp Riverside and Grover. Possible error in the Floodplain map in the Grover area. Will meet with Council end of Nov. or at Regular December meeting. *Bruha informed Council that a meeting of the Board of Adjustments will need to be scheduled due to a variance that was granted and a new home permit. *Each Council received information regarding the Team Mates Program of NE. *After the concern reported by Jack Zimmerman at the last regular meeting regarding noise control Chief of Police Siebken noted that 12 defects had been written on loud vehicles with faulty exhausts.

NEW BUSINESS:

Water Rate Increase: Fortune reported that he and Mark Frey had met with Gil Frey from NE Rural Water Assoc. regarding a study of the water rates due to the fact that budget figures had not been met the last couple years.

Gil Frey presented a three-phase proposal, which would adjust the water rates gradually for the next 3 years. The first 2 years adjustment would increase the annual water rate income approximately \$10,000. The third year would increase approximately \$6,000. The estimated study was calculated by a database of 42,000 water users and current information gathered by City Hall. It was noted that after this 3 year phase the rates should be checked into again. Water projects discussed for the near future were the water tower and possibly a new well. A motion was made by Fortune and seconded by Bockoven to have Attorney Blevens draw up an ordinance with water rate changes for the December meeting. Roll call vote: Fortune yes, Bockoven yes, Burroughs yes, Cooper yes. Motion carried.

Appointments: A motion was made by Fortune and seconded by Cooper to approve the Mayors recommendation of Ruth L. McCullick to the Housing Authority for a 5 year term beginning December 1, 2000. Roll call vote: Fortune yes, Cooper yes, Bockoven yes, Burroughs yes. Motion carried.

A motion was made by Burroughs and seconded by Fortune to approve the Mayors recommendation of Warren Spellman to the Milford Aging Commission for a 3 year term beginning January 2001. Roll call vote: Burroughs yes, Fortune yes, Bockoven yes, Cooper yes. Motion carried.

Introduction and Adoption of Ordinance – Noise: Councilmember Cooper introduced the following ordinance:

ORDINANCE NO. 709

AN ORDINANCE TO ADD SECTION 6-334 TO THE MILFORD MUNICIPAL CODE RELATING TO EXCESSIVE NOISE; TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. (See Ordinance Record)

Proposals for Storm Sewer Discharge System, west of Coop: Cooper presented the proposals from Kirkham Michael and Olsson Assoc. as information only. More time was needed to carefully look them over. Item tabled to December meeting.

Approval to go out for bids – **Dump Truck:** A set of specifications was presented to the Council by the maintenance dept. A new dump truck was discussed at budget prep. to replace the 1965 "baby dump truck". The maintenance dept. felt they could use this vehicle to haul larger items from Lincoln as they are currently using the pickups. A motion was made by Cooper and seconded by Fortune to go out for bids on a new dump truck. Roll call vote: Cooper yes, Fortune yes, Bockoven yes, Burroughs yes. Motion carried.

Flashing Lights on State Street: Cooper had approached 4 different contractors for proposals to place flashing lights on both ends of State Street

thru the S.C.C. campus. Gene's Electric and Kayton Electric were the 2 proposals returned and presented to the Council. Discussion was held as to whether the lights needed a timer. Fortune asked if the lights were needed and if needed at both ends. Cooper felt they were due to the number of students crossing the street. Chief Siebken felt the timer was a good idea. A motion was made by Cooper and seconded by Fortune to accept the bid from Kayton Electric for option #2 in the amount of \$4,246.00 and the addition of time clocks for \$1,200.00 with boring for conduit at \$12.00 per ft. Roll call vote: Cooper yes, Fortune yes, Bockoven yes, Burroughs yes. Motion carried.

Approval to take bids for ball field lights: Burroughs advised Council that the City had 7 60' poles, 3 – 4 shorter poles and 124 light fixtures that were just being stored since they were removed from Welch Park ball fields. He would like to keep 24 of the fixtures for use at the pool and other possible areas. Some of the fixtures did not work and would have to be sold "as is". A motion was made by Burroughs and seconded by Bockoven to advertise the sale of 7 60' poles, 3-4 shorter poles and 100 light fixtures in their current condition. Roll call vote: Burroughs yes, Bockoven yes, Cooper yes, Fortune yes. Motion carried.

Executive Session – Litigation: A motion was made by Fortune and seconded by Burroughs to go into Executive Session. Roll call vote: Fortune yes, Burroughs yes, Bockoven yes, Cooper yes. Motion carried and Council adjourned from regular session at 8:14 p.m.

A motion was made by Bockoven and seconded by Cooper to return to Regular Session. Roll call vote: Bockoven yes, Cooper yes, Burroughs yes, Fortune yes. Motion carried and Council returned to regular session at 8:40 p.m.

ADJOURNMENT: A motion was made by Bockoven and seconded by Burroughs to adjourn the meeting. Roll call vote: Bockoven yes, Burroughs yes, Cooper yes, Fortune yes. Motion carried and meeting adjourned at 8:40 p.m.
