REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written
reports received were Housing Authority minutes for September 10, 2001;
Planning & Zoning minutes for September 18, 2001; Milford Aging
Services Commission minutes for September 19, 2001; Police Dept. Activity
Report for September 2001. Cooper - Improvements of the alley behind
Sister Act have been made according to the survey results of our last
meeting. Olsson Assoc. has been contacted to survey the alley behind
Rediger Chevrolet. Discussion has been held on a design for the alley

approach on "B" Street between 5th & 6th St. <u>Neal</u> – Sr. Center Board met and discussed the deficit. Efforts are being made to come up with ways to bring in additional funds. Meal contract presented was the same cost as last year. <u>Siebken</u> – 794 total calls for service. Members of the Seward County E911 Agency Board traveled to West Point to look at their communication systems. Several items are on the table and it looks like the 300' tower will probably not occur in Seward County. Agency Board is looking at possibly a multiple repeater sight or trunk UHF System.

COMMUNICATIONS: Sales tax received for the month of July 2001 was \$11,348.24. Mayor Plessel visited with County Clerk, Schweitzer to discuss changing the voting wards within the City of Milford. With a population of 2070, the ideal number would be 1035 per ward. We are currently: Ward 1-975 and Ward 2 – 1095. This allows for an 11.6% deviation and the maximum deviation should be 10%. By using 3^{rd} St. as the dividing line from one end of the City limits to the other, the numbers would be as follows: Ward 1 – 1037 and Ward 2 – 1033. The County Clerk needs the change made by Ordinance before November 1^{st} . Mayor Plessel requested a special meeting be held. October 8, 2001 at 5:00 pm was the date decided for the special meeting.

PUBLIC HEARING: Citizen Advisory Committee: Mayor Plessel opened the public hearing at 7:40 pm. Dean Bruha advised the Council that the Economic Development Committee met Sept. 27th and is still trying to solicit business to the community. Bruha has received several calls from local business wanting to expand and/or make improvements. He explained that the State funds are tied to new jobs created. Funds for the immediate community would come from the .10%, which has been set aside from sales tax income. A company has inquired about a distribution sight. Locations within the county have been looked at. This process is very competitive and the company naturally is looking out for their best interest. Bruha informed the Council that activity is taking place. The group is pursuing locations inside and out of the city limits of interested parties to sell ground. They will then list these properties on the website for promotional sites. No expenditures at this time. Neal added, the group couldn't actively promote a sight unless they have an agreement. There being no further comments the Mayor closed the public hearing at 7:45 pm.

UNFINISHED BUSINESS:

Executive Session – Litigation: A motion was made by Burroughs and seconded by Neal to go into Executive Session. Roll call vote: Burroughs yes, Neal yes, Cooper yes. Motion carried and the Council adjourned from regular session at 7:45 pm. A motion was made by Cooper and seconded by

Burroughs to return to regular session. Roll call vote: Cooper yes, Burroughs yes, Neal yes. Motion carried and Council returned to regular session at 8:30 pm.

Water Damage – Meierdierks & Rediger: A motion was made by Cooper and seconded by Burroughs to table this item until the Nov. 6th meeting. Roll call vote: Cooper yes, Burroughs yes, Neal yes. Motion carried.

NEW BUSINESS:

Award Sr. Center Meal Bid: A motion was made by Neal and seconded by Cooper to award the Sr. Center meal bid to Sunrise Country Manor in the amount of \$3.00 per meal. Roll call vote: Neal yes, Cooper yes, Burroughs yes. Motion carried.

Stand-by Generator: Burroughs reported that the generator has been maintained and is operational. In order to hook it up, a transformer and throw switch need to be installed. Fortune received an estimate from Gene's Electric of \$19,650.00. Fortune has reviewed the bid. A motion was made by Burroughs and seconded by Cooper to accept the bid from Gene's Electric in the amount of \$19,650.00 to install the transformer and switch to the generator. Roll call vote: Burroughs yes, Cooper yes, Neal yes. Motion carried.

Hire Volleyball Director: A motion was made by Burroughs and seconded by Neal to accept the recommendation of the Recreation Board to hire Monty Troyer as the Volleyball Director. Roll call vote: Burroughs yes, Neal yes, Cooper yes. Motion carried.

Youth Basketball Coaches: A motion was made by Burroughs and seconded by Neal to accept the recommendation of the Recreation Board to hire Eric Millikan as the youth boy's basketball coach for the Saturday morning program. Roll call vote: Burroughs yes, Neal yes, Cooper yes. Motion carried. It was mentioned that a girl's coach has not been found yet.

Beverly TeSelle – Concerns about 725 1^{st} **St.:** Larry and Bev TeSelle own the property directly west of 725 1^{st} St. Bev presented pictures of the property noting the condition of the roof and porch roof. There are holes in the roof, which a squirrel could take a cigarette into and cause a fire. The appearance is poor for anyone traveling on 1^{st} St. There are three storage units, in the back yard, that are never used. Mrs. TeSelle is concerned about mice and snakes in the storage buildings. An issue for the police dept., a vehicle is normally parked over the sidewalk in front of the house. Mr. Bruha noted to the Council that a Housing Authority should be created to inspect rental properties on an annual basis. If inspection fails and repairs are not made within 30 days then the Certificate of Occupancy would be removed. Neal questioned if codes were in place to relate to the issues in the photos. Blevens noted the Uniform Building Code should have a section to abate a nuisance. The Council decided to have Building Inspector Roger Kness inspect the property and report back to the City Council in November. TeSelle's main concern is a fire hazard.

Award Bid – "A" Street Storm Sewer: Cooper reported that Sealcoat Services out of Omaha turned in the low bid of \$34,059.50. Kirkham Michael has worked with them before and they stated that they could start on the project this fall. Burroughs noticed we had a local contractor that turned in a bid of only \$2,000.00 more. Cooper felt \$2,000 would make a difference in the street budget. A motion was made by Cooper and seconded by Burroughs to award the bid to Sealcoat Services in the amount of \$34,059.50 for the "A" Street Storm Sewer Project. Roll call vote: Cooper yes, Burroughs yes, Neal yes. Motion carried.

Approve Payment –Olsson Assoc., Valley View Lift Station: A motion was made by Neal and seconded by Cooper to approve payment of Invoice #48952 in the amount of \$550.00 to Olsson Associates for 10% of the completed project for the Valley View Lift Station. Roll call vote: Neal yes, Cooper yes, Burroughs yes. Motion carried.

Approve payment – Kirkham Michael, Flood Mitigation: A motion was made by Burroughs and seconded by Neal to approve payment in the amount of \$334.00 to Kirkham Michael for the flood mitigation study. Roll call vote: Burroughs yes, Neal yes, Cooper yes. Motion carried.

Approve Fire Dept. Membership Roster: A motion was made by Burroughs and seconded by Cooper to approve the Fire Dept. membership roster. Roll call vote: Burroughs yes, Cooper yes, Neal yes. Motion carried. **Introduction and Adoption of Resolution - R.A.P.:** Attorney Blevens read the resolution. A motion was made by Burroughs to approve the following resolution seconded by Neal.

RESOLUTION NO. 380

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MILFORD, NEBRASKA:

WHEREAS, law enforcement agencies within the following counties: Butler, Clay, Fillmore, Hamilton, Jefferson, Merrick, Nuckolls, Saline, Saunders, Seward, Thayer, Webster, and York desire to enter into a cooperative law enforcement effort; and

WHEREAS, the above agencies have submitted a grant application as the RURAL APPREHENSION PROGRAM (hereafter R.A.P.); and

WHEREAS, the R.A.P. project has been funded by the Nebraska Crime Commission; and

WHEREAS, the various counties, agencies and communities within those counties desire to make the most efficient use of the power by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors; and

WHEREAS, an interlocal agreement, consistent with Nebraska Revised Statutes 13-801 et.seq., would be in the best interest of all participating agencies; and

WHEREAS, the agencies desire to enter into a written interlocal agreement for the purpose of carrying out the R.A.P. objectives and grant requirement of the Nebraska Crime Commission.

BE IT RESOLVED THAT:

The City of Milford authorizes R.A.P. to enter City of Milford into an interlocal agreement for joint and cooperative action pursuant to the provisions of Section 13-801 through 13-807. The interlocal agreement shall be for the strict administration of the R.A.P. project and all funds allocated by the Nebraska Crime Commission, and Match dollars allocated by the R.A.P. members. Further, this interlocal agreement shall not establish a separate legal entity, rather as a joint and cooperative undertaking between public agencies i.e. state, county, city and village. (Nebraska Revised Statute 13-801)

Amount of match dollars allocated by the City of Milford for the 2001 - 2002 (R.A.P. 12) grant period will be \$943.00.

Upon roll call vote as follows: Burroughs yes, Neal yes, Cooper yes. Motion carried.

Passing this ordinance would make the manager or property owner more responsible for activities being allowed which disturb public peace. Fine of \$500.00 could be assessed. Chief Siebken

informed the Council of an incident in Lincoln and after the ordinance was passed they noticed a decrease in disturbance calls. A motion was made by Cooper and seconded by Burroughs to introduce the following Ordinance:

ORDINANCE NO. 718

AN ORDINANCE ENACTING ARTICLE 5, TO THE MILFORD MUNICIPAL CODE RELATING TO OFFENSES AGAINST PUBLIC PEACE; TO ENACT SECTIONS 6-501 THROUGH 6-505 RELATING TO THE SUPPRESSION OF NUISANCES TO INCLUDE UNREASONABLE INTERFERENCES WITH THE HEALTH, SAFETY, WELFARE AND PROPERTY OF THE CITIZENS OF THE CITY AS A NUISANCE; TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. Executive Session – Personnel: A motion was made by Neal and seconded by Burroughs to go into Executive Session. Roll call vote: Neal yes, Burroughs yes, Cooper yes. Motion carried and Council adjourned from regular session at 9:00 pm. A motion was made by Burroughs and seconded by Cooper to return to regular session. Roll call vote: Burroughs yes, Cooper yes, Neal yes. Motion carried and Council returned to regular session at 9:11 pm.

ADJOURNMENT: A motion was made by Burroughs and seconded by Cooper to adjourn the meeting. Roll call vote: Burroughs yes, Cooper yes, Neal yes. Motion carried and meeting adjourned at 9:12 pm.
