**REPORTS OF OFFICERS, BOARDS AND COMMITTEES:** Written reports received were Planning & Zoning minutes for August 14, 2003, Milford Aging Services Commission minutes for August 26, 2003; Recreation Board minutes for August 12, 2003 and Police Dept. Activity Report for August 2003. <u>Chief Siebken</u> reviewed the August activity report noting 990 calls for service for the month of August. Chief Siebken completed the 2 week training course as a DARE Instructor.

**COMMUNICATIONS:** Sales tax received for the month of June 2003 was \$10,846.03. Received N.P.P.D. 2<sup>nd</sup> quarter lease payment in the amount of \$30,021.65.

## **NEW BUSINESS:**

**Award Bid – Sr. Center Meals:** A motion was made by Anderson and seconded by Neal to approve the bid submitted by Sunrise Country Manor in the amount of \$3.35 per meal. This is an increase of .10 from last year. Roll call vote: Anderson yes, Neal yes, Bruha yes, Fortune yes. Motion carried.

Non-Smoking Legislative Action, Mark Welsch: Mark Welsch noted that the idea behind the Ordinance is to put Milford on the map as being the #1 City to pass this type of ordinance and be completely smoke free. Mark stated that Lincoln is in the works of passing such an Ordinance. A survey was sent to Milford resident registered voters by Welsch. He has received 28 returned surveys as of 9/2/03. A few statistics were reviewed by Welsch regarding the survey. Neal commented that this is a sensitive issue and would like to allow for additional public input. Mark Welsch noted that this would be a source of free publicity for Milford. The Ordinance presented by Blevens is basically the same as Welsch provided. (A copy of this information is being made a permanent part of these minutes.) The City of Milford is currently following the State guidelines of the NE Clean Air Act. All public businesses are smoke free. The bars are given the choice by State law as to whether they want their business to be smoke free or not. Fortune commented the City shouldn't regulate how a business conducts themselves. It is wrong to supersede the State law. Mayor Plessel advised the Council that after reviewing the sample ordinance if they felt the need to place this issue on next months agenda to do so.

**Approve Payment – Olsson Assoc., Water Tower:** A motion was made by Fortune and seconded by Neal to approve payment of invoice #60892 in the amount of \$3,252.23 for engineering services on the new Water Tower. Roll call vote: Fortune yes, Neal yes, Anderson yes, Bruha yes. Motion carried.

**Approve Payment – Maguire Iron, Certificate #7:** A motion was made by Fortune and seconded by Bruha to approve payment to Maguire Iron for certificate of payment #7 in the amount of \$65,403.00. Roll call vote: Fortune yes, Bruha yes, Anderson yes, Neal yes. Motion carried.

**ADJOURNMENT:** A motion was made by Fortune and seconded by Anderson to adjourn the meeting. Roll call vote: Fortune yes, Anderson yes, Bruha yes, Neal yes. Motion carried and meeting adjourned at 8:05 pm.
