UNFINISHED BUSINESS:

Drainage Study Proposal: Jay Bittner with the Upper Big Blue Natural Resources District presented information outlining the planning stages of a community wide drainage study. The end result will give the City a map with contours every ½ foot showing direction of water flow and size of recommended piping for drainage. Potential developers can use this information to create subdivisions with adequate storm sewer drainage. NRD will provide funding for 25% of the total project. The City's portion is \$46,500, NRD \$15,500 totaling \$62,000. Aerial photography is the big ticket item (\$26,000) they offered to spread out payment over a 2 year period. A motion was made by Bruha and seconded by Baker to table item until next month. Roll call vote: Bruha yes, Baker yes, Fortune absent, Neal yes. Motion carried.

NEW BUSINESS:

Introduction and Adoption of Resolution – Exceed Budget Limit by 1%:

Discussion was held regarding George Matzen's hourly rate. George was hired as Library Director in May 2008 establishing a new full time position. He is on probation for 1 year and the Council agreed to leave his hourly rate at \$10.00 until his probation period is over.
