# CITY OF MILFORD REGULAR MEETING SEPTEMBER 4, 2007 MINUTES

A regular meeting of the Mayor and Council of the City of Milford, Nebraska was held at the Webermeier Library Community Room in said City on the 4<sup>th</sup> day of September 2007 at 7:30 pm. REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Milford Aging Services Commission minutes for August 28, 2007; Board of Adjustment minutes from August 29, 2007; Pool Board minutes from August 21, 2007 and August 28 2007; Park Board minutes from August 9, 2007; Police Dept. Activity Report for August 2007 and Rescue NARSIS reports for August 2007. Baker was just notified that the Sr. Center basement has mold in the SE corner of the building. He will look at it after tonight's meeting. Bruha – maintenance crew busy with tree clean up. Chief Siebken reviewed the August Police Dept. activity report. Siebken will be attending DARE America for mentoring training in Kansas City. Wayne Stohlman – did not experience too much damage with the storms. Chief Siebken announced the NIMS training for 100, 200, 700 & 800 will be held at the Milford Fire Station on Sept. 12, 2007 at 6:00 pm.

**COMMUNICATIONS:** \*Sales tax received for the month of June 2007 was \$11,240.90. \*NPPD lease agreement payment for the second quarter 2007 received in the amount of \$33,040.79.

#### **UNFINISHED BUSINESS:**

**Sidewalks, west side of "D" Street & west side of "F" Street north of Hwy 6:** Bruha explained the right-of-way circumstances with both intersections. "F" Street is 66' wide with plenty of room for a sidewalk. There are some bushes that may need to be removed. "D" Street will require a different approach and Bruha was not able to speak with Sean Kremer. There is approximately 15' from the curb to the building on "D" Street. Bruha will proceed by gathering more information.

**Review and approve E-911 Budget:** Chief Siebken presented the Seward County E-911 Budget form, explaining that there was an \$11,000.00 reduction from the original. There was an overall 4.59% increase from last year. Milford will continue to pay their 4%, which totals approximately \$18,442.00. A motion was made by Neal and seconded by Bruha to approve the Seward County E-911 Budget. Roll call vote: Neal yes, Bruha yes, Baker yes, Fortune yes. Motion carried.

#### **NEW BUSINESS:**

**Appointments – Milford Aging & Library:** A motion was made by Baker and seconded by Neal to approve the Mayor's recommendation of appointing Doris Kunze to the Milford Aging Services Commission to complete Marvin Weber's term expiring January 31, 2009. Roll call vote: Baker yes, Neal yes, Bruha yes, Fortune yes. Motion carried.

A motion was made by Fortune and seconded by Bruha to approve the Mayor's recommendation to appoint Susan Weber to the Library Board as her 1<sup>st</sup> term, replacing Phyllis Koch. Susan's 1<sup>st</sup> term will expire September 30, 2011. Roll call vote: Fortune yes, Bruha yes, Baker yes, Neal yes. Motion carried.

Award Bid – Sr. Meals: A motion was made by Baker and seconded by Neal to award the meal bid to Sunrise Country Manor at \$3.25 per meal. Roll call vote: Baker yes, Neal yes, Bruha yes, Fortune yes. Motion carried. Award Bid – General Insurance: Three companies bid the general insurance, which were opened on Friday, August 31, 2007. <u>Davidson Insurance and Ball Insurance</u> joined together to present a bid of \$45,617.90. General insurance - \$37,399.00, Fire & Rescue Pak - \$5,689.00, Fire & Rescue workers comp. - \$2,529.90. Mark Davidson and Larry Ball presented information regarding their proposal through Continental Western. The Fire Pak has a 3 year rate guarantee and renewal discounts. Larry explained many situations in which their insurance carrier would cover the occurrence.

<u>InsureNebraska</u> did not have a representative present but submitted 2 options to their bid. Option #1 – Homestate Co. - \$49,025. Option #2 – Homestate Co. and VFIS - \$51,573.

<u>INSPRO Insurance</u> submitted a bid through EMC (Employers Mutual) for \$44,923. Becky Haufle and Vicky Roth presented information to the Council regarding their proposal. Their bid proposal was based on what coverage we currently have. Becky commented that a review of valuations would be conducted if they were chosen.

The City Council decided to take some time to review the information and make their decision at the Special meeting on Sept. 13, 2007.

Introduction and Adoption of Resolution - RAP: A motion was made by Bruha and seconded by Baker to approve the following resolution:

**RESOLUTION NO. 432** 

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MILFORD, NEBRASKA:

WHEREAS, law enforcement agencies with the following counties: Butler, Clay, Fillmore, Hamilton, Jefferson, Merrick, Nuckolls, Saunders, Seward, Thayer, Webster, and York desire to enter into a cooperative law enforcement effort; and WHEREAS, the above agencies have submitted a grant application known as the RURAL APPREHENSION PROGRAM (hereafter RAP 17); AND

WHEREAS, the RAP project has been funded by the Nebraska Crime Commission; and

WHEREAS, the various counties, communities and agencies within those jurisdictions desire to make the most efficient use of their power by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors; and

WHEREAS, an interlocal agreement, consistent with Nebraska Revised Statutes 13-801et.seq, would be in the best interest of all participating agencies; and

WHEREAS, the agencies desire to enter into a written interlocal agreement for the purpose of carrying out the RAP objectives and grant requirement of the Nebraska Crime Commission.

## BE IT RESOLVED THAT:

The City of Milford authorizes the Chief of Police, Forrest Siebken to enter City of Milford into an interlocal agreement for joint and cooperative action pursuant to the provisions of Section 13-801 through 13-807 of Nebraska Revised Statutes. The interlocal agreement shall be for the strict administration of the RAP project and all funds allocated by the Nebraska Crime Commission, and Match dollars allocated by the RAP members. Further, this interlocal agreement shall not establish a separate legal entity, rather as a joint and cooperative undertaking between public agencies i.e. county, city and village. (Nebraska Revised Statute 13-801)

Amount of match dollars allocated by the City of Milford for the 2007 - 2008 grant period (RAP 17) will be \$1035.00.

Upon roll call vote as follows: Bruha yes, Baker yes, Fortune yes, Neal yes. Motion carried.
