**REPORTS OF OFFICERS, BOARDS AND COMMITTEES:** Written reports received were Milford Aging Services Commission minutes for June 28, 2011; Planning & Zoning Commission minutes for June 20, 2011; Swimming Pool Board minutes for June 28, 2011; Police Dept. activity report for June 2011; Milford Fire and Rescue NARSIS report for June 2011. <u>Baker</u> met at the Sr. Center on June 28<sup>th</sup> and discussion was held regarding fund raising and budget. The Potato Bake is scheduled for Friday night of Fun Days. <u>Chief Siebken</u> highlighted his monthly report and informed the Council of 116 plus vehicles that were painted during the night. A witness saw 3 individuals dressed in black but were never apprehended. <u>Heckman</u> met with the Pool Board on June 28 and they are having JEO bring back some options on the Pool expansion project. The diving board should be here tomorrow.

**UNFINISHED BUSINESS:** 

**Form an Employee Handbook Review Committee:** Baker and Hoggins contacted the NE League of Municipalities and discovered that they do not have a template Employee Handbook but other communities could be contacted. Hoggins was referred to HR Director Sheila Schukei with the City of Norfolk and she suggested using an Attorney or if it wasn't too time consuming she would be able to take a look at ours. Fortune mentioned that Dorothy Bockoven helped with the 1<sup>st</sup> draft but we would need to research current law changes. It was decided to wait until after budget to pick up on this project.

## **NEW BUSINESS:**

## **Economic Development Presentation – Lana Rourke & Ryne Seaman:**

Ryne Seaman spoke on behalf of the Seward Area Development Corporation which is directly working with the Seward County Economic Development Committee. The joint task force has been working towards reviewing the existing economic development activities, developing a new structure to better serve the county, formulating a long-term budget and enhance reporting and accountability. SADC has a 12 member board. The group is asking for Milford to continue with its support of economic development at 5% or approximately \$4750.00 for 2011-2012. Discussion was held regarding projects that are currently being negotiated along with projects that have already been established. In Milford the projects noted were: Digitec, J & R Welding, CY Manufacturing and Wayne & Stacy Hartgerink. The group encouraged Milford to put together a group of "go-to" people within the community for future input or communication during a project. A new proposal is under way which would disband the current Interlocal Agreement and allow for private involvement. They would also like to see involvement of 1 Councilmember from Milford on the Board.
