REPORTS OF OFFICERS, BOARDS AND COMMITTEES: Written reports received were Milford Housing Authority minutes for September 13, 2012; Milford Aging Services Commission minutes for September 25, 2012; Pool Board minutes for September 25, 2012; Recreation Board minutes for September 25, 2012; MVFD Fire & Rescue NARSIS Report for September 2012 and Milford Economic Development Committee minutes for September 5, 2012.

COMMUNICATIONS: *Sales tax received for the month of July 2012 in the amount of \$16,005.92. *NPPD proposed rate increase overall at 3.75% for 2013.

PUBLIC HEARINGS:

Application for Class D Liquor License for STOP N SHOP at 410 S. Hwy 6: Mayor Bruha opened the Public Hearing at 7:45 pm. Jason Laessig owner/operator of Stop n Shop introduced himself and gave a brief outline of his history. In 2007 he started his business with Stop N Shop and currently has stores in Weeping Water, Crete, Lincoln and now Milford. He is heavily involved in the community where he has stores. He is asking for a Class D license because that is what his other stores currently have. He is experienced in selling not only beer but also wine and spirits. He has reached out to S.C.C. president Dr. Huck and Seward County Sheriff Joe Yocum and they both take no stance for or against the issue. Chief Siebken

was unavailable when he called. He has had no issues in the other towns. Mayor Bruha questioned what would be eliminated from the store to display the additional wine and spirits. Laessig - They have removed a lot of freezers and there is a 4' section available for the display. The smaller bottles will be located behind the counter. There being no further comments from the public Mayor Bruha closed the public hearing at 7:50 pm.

Alcohol Sales on Sunday within the corporate limits: Mayor Bruha opened the public hearing at 7:51 pm. He asked if there was anyone that wanted to speak on behalf of the item. Don Eberspacher spoke against the issue. His first thought was, do we really need it? Alcoholism is a disease and affects you & me. He gave statistics on binge drinking and the number of people that drink over the age of 15. Sunday is a day set aside for Church and rest. Alcohol brings grief and problems to the area. He is commenting against this issue as he does not want to be responsible. Mr. Eberspacher is asking the Council to deny the sale of alcohol on Sunday in the corporate limits of Milford. Connie Hoile appreciates the thoughts and comments of Mr. Eberspacher. The City of Milford is losing out by people going out of town to do their one stop shopping. They will drive to the interstate to buy gas and pick up alcohol while they are there. She would like to see the tax dollars stay in Milford. Jason Laessig added that there is viable business on Sunday. People will go out of town and this is a substantial chunk of change. Sheila Eberspacher noted that alcohol may be consumed on Sunday but she has always prided herself in being able to say that Milford is alcohol sales free on Sunday. Ït's really kind of a neat thing." There being no further comments Mayor Bruha closed the public hearing at 8:04 pm.

Citizen Advisory Committee: Mayor Bruha opened the public hearing at 8:05 pm. He explained LB840 and how it is used in Milford. There is currently a balance of \$150,344.55. Within the last couple months there has been quite a bit of activity in Milford involving Economic Development. Mayor Bruha explained the typical process of an application and that they have in the past given a grant to the recipient that will not be paid back and also an interest free loan which will be paid back in 4 years. This allows the entrepreneur to get their feet on the ground and sustain themselves. No further comments Mayor Bruha closed the public hearing at 8:07 pm.

UNFINISHED BUSINESS:

Introduction and Adoption of Ordinance – Recreational Fires/Fire Pits: Council member Fortune introduced the following ordinance adding the exception to the proposed ordinance:

ORDINANCE NO. 863

AN ORDINANCE TO ADD SECTION 7-213 TO THE MILFORD MUNICIPAL CODE RELATING TO RECREATIONAL FIRES; TO

PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. (See Ordinance Record)

Action on Rental Agreements – Fire Hall, Webermeier Bldg., Sr Center: It was noted that changes need to be made to the agreements and then follow thru with the guidelines set. Mayor Bruha mentioned that before a deposit is returned the buildings should be thoroughly inspected.

NEW BUSINESS:

Introduction and Adoption of Resolution – Application for Class D Liquor License for STOP N SHOP: Fortune made a recommendation to approve the license change for STOP N SHOP. With no further comments Council member Fortune introduced the adoption of the following resolution:

RESOLUTION NO. 481

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITYOF MILFORD, NEBRASKA

WHEREAS the Mayor and Council have conducted a public hearing upon the issuance of a Class D liquor license to Stop 'N Shop #4, located at 410 S. State Highway #6, in the City of Milford, Seward County, Nebraska and have no objections to the issuance of said license.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council hereby recommend to the Nebraska Liquor Control Commission that a Class "D" license be issued to said applicant, Stop 'N Shop #4, for the location at 410 S. State Highway #6, in the City of Milford, Seward County, Nebraska.

Action on Alcohol Sales on Sunday within the Corporate Limits: Fortune has had conversation with local business owners and the Golf Course is having issues with this. He understands what the Eberspachers are saying but because we are just minutes from other places that sell alcohol we are missing out on sales that are being sent down the road. Fortune would be in favor of some type of sales and the hours can be discussed. Kral has spoken with several people that are on the Board at the Golf Course and he understands that the golf course is struggling. Kral recognizes the quality of

input but if someone can go down the road and spend the money rather than spending it here, we can't alter behavior but we could alter spending. Kral would be in favor of allowing this to occur to keep the golf course solvent. Hours and types of alcohol were discussed. Bruha mentioned that he would like it if the community could stay alcohol free on Sunday. A motion was made by Fortune and seconded by Kral to introduce the following ordinance:

ORDINANCE NO. 864

AN ORDINANCE TO SET THE HOURS OF SALE OF ALCOHOLIC BEVERAGES WITHIN THE CITY OF MILFORD, NEBRASKA; TO ALLOW THE SALE OF ALCOHOLIC BEVERAGES ON SUNDAY; TO PRESCRIBE THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT, AND TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH. (See Ordinance Record)

Approve Coed Volleyball Director and Youth Basketball Coaches: A motion was made by Baker and seconded by Kral to approve Bruce Stutzman as the Coed Volleyball Director and Craig Bontrager as the youth Basketball Coach. Roll call vote: Baker yes, Kral yes, Fortune yes, Heckman yes. Motion carried.

Approve Fire Dept. membership roster: A motion was made by Kral and seconded by Heckman to approve the Fire Dept. roster as submitted with 42 members. Roll call vote: Kral yes, Heckman yes, Baker yes, Fortune yes. Motion carried.

Introduction and Adoption of Ordinance – Vacate west 100 feet of alley between 2nd & 3rd St. and E & F St.: A motion was made by Council member Kral to introduce the following ordinance:

ORDINANCE NO. 865

AN ORDINANCE OF THE CITY OF MILFORD, NEBRASKA TO VACATE THE WEST 100 FEET OF THE ALLEY IN THE CITY OF MILFORD, NEBRASKA, BEING THE WEST 100 FEET OF THE ALLEY RUNNING EAST AND WEST WHICH IS LOCATED BETWEEN SECOND STREET AND THIRD STREET AND BETWEEN F STREET AND E STREET, IN THE CITY OF MILFORD, SEWARD COUNTY, NEBRASKA; TO RETAIN AN EASEMENT OVER AND ACROSS SAID ALLEY FOR LOCATION OF WATER, SEWER, ELECTRICAL, TELEPHONE, UTILITIES, AND OTHER MUNICIPAL PURPOSES AND FOR PURPOSES OF INGRESS AND EGRESS TO THE CITY OF MILFORD, NEBRASKA AND THE GENERAL PUBLIC, TO PROVIDE FOR THE MAINTENANCE OF SAID ALLEY; TO PROVIDE THE MANNER FOR DETERMINATION OF DAMAGES BY CITIZENS OF THE CITY OR BY OWNERS OF PROPERTY THEREIN; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PRESCRIBING

THE TIME THIS ORDINANCE SHALL BE IN FORCE AND TAKE EFFECT. (See Ordinance Record)

Request for Economic Development Funding – Kathi Schildt: Mayor Bruha read the minutes provided by the Milford Economic Development Committee. (Copy of minutes attached) Council member Baker noted a professional conflict of interest and eliminated himself from the vote. A motion was made by Kral and seconded by Fortune to approve the recommendation of economic development funding for Kathi Schildt dba Advanced Association Management LLC in the amount of a \$20,000.00 grant and a \$20,000.00 loan at 0% interest over four (4) years. Roll call vote: Kral yes, Fortune yes, Heckman yes. Motion carried.

Discussion of Rescue/Fire Billing: Council member Kral noted the Fire Dept. has researched this area and would like to share their finding. Marcy Hostetler presented the information which is attached and has become part of the official minutes. (See attached)

Action on Franchise Agreement with Unite Private Networks, LLC: There are still some questions that need to be researched. Council decided to table this action until next month.

Salary Adjustment: Mayor Bruha noted that during budget and salary discussion he neglected to highlight Ben Rediger's performance and would like to at this time ask the Council to consider increasing his hourly rate by \$1.00. This would adjust his rate from \$14.72 to \$15.72. He is currently being paid 100% out of the Parks Dept. His salary could be divided 75% out of Parks and 25% out of Streets. Baker did not disagree that Ben has a good work ethic but did not want to set precedence and have to deal with another request for increase. The Council discussed having Ben get certified in water which would increase his responsibilities and at that point a raise would be forthcoming. A motion was made by Kral and seconded by Fortune to increase Ben Redigers' hourly rate by \$1.00 contingent on him receiving his water certification. Roll call vote: Kral yes, Fortune yes, Baker yes, Heckman yes. Motion carried.

Introduction and Adoption of Resolution - R.A.P. Program: Attorney Blevens read the proposed resolution. A motion was made by Kral to introduce and adopt the following resolution:

RESOLUTION NO. 482

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MILFORD, NEBRASKA:

WHEREAS, law enforcement agencies with the following counties: Butler, Fillmore, Hamilton, Jefferson, Merrick, Polk, Saunders, Seward, Thayer, Webster, and York desire to enter into a cooperative law enforcement effort; and

WHEREAS, the various counties, communities, and agencies within those jurisdictions desire to make the most efficient use of the power by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors; and

WHEREAS, an interlocal agreement, consistent with Nebraska Revised Statutes 13-801 et.seq., would be in the best interest of all participating agencies; and

WHEREAS, the agencies desire to enter into a written interlocal agreement for the purpose of carrying out the R.A.P. objectives.

BE IT RESOLVED THAT:

The City of Milford authorizes Chief Forrest Siebken to enter the City of Milford into an interlocal agreement for joint and cooperative action pursuant to the provisions of Section 13-801 through 13-807 of Nebraska Revised Statutes. The interlocal agreement shall be for the strict administration of the R.A.P. project and all funds allocated by the RAP members. Further, this interlocal agreement shall not establish a separate legal entity, rather as a joint and cooperative undertaking between public agencies i.e. state, county, city and village. (Nebraska Revised Statute 13-801)

Amount of match dollars allocated by the City of Milford for the 2012- 2013 grant period (RAP 23) will be \$1035.00. (2000 census 2,070 x \$0.50)

Upon roll call vote as follows: Kral yes, Heckman yes, Baker yes, Fortune yes. Motion carried.
