PRESENTATION:

Milford Fire Dept. – Jr. Firefighters & EMS Program: Tim Stewart with the Milford Volunteer Fire Dept. presented information on the Jr. Firefighters & EMS Program. The program is sanctioned by the Boy Scouts of America for both boys and girls ages 14 – 20. Rules & Guidelines were presented to the City Council for consideration. There is an annual fee of \$75.00 per participant of which \$42.00 goes to the Boy Scouts to pay for the insurance. The Fire Dept. will pay \$35.00 to provide CPR class for each participant. Stewart stated, "It is a great program." He is asking permission to move forward. Mayor Kelley questioned if it is geared more towards the fire department? Stewart noted, it is geared for both fire & rescue. Discussion was held regarding 14 & 15 year old's responding to the station or the scene. The Council asked for specifics relating to 14 & 15-year-old participation. They also asked for specifics to be added to the guidelines for all different ages so there was no discrepancy as to how the participant could be involved. The explorer must maintain a 2.5 GPA. Scholarships will be offered as a resource for funding. The program will be offered to Milford High School students. Attorney Fahleson noted the Reduction of Risk to have training for adults to be around kids. There are training

requirements spelled out as part of the Boy Scout Program. All training must be completed prior to program starting. Mayor Kelley suggested reviewing the guidelines annually.

Tim will revise the guidelines and present them to the City Council in January for further review.

Notice of Award for the City of Milford Downtown Revitalization Program Grant from Nebraska Department of Economic Development: The City of Milford was awarded a Community Development Block Grant up to \$53,000.00 to be used for Downtown Revitalization (DTR) Planning/Pre-development. Jonathan Jank with SCCDP and Tom Bliss with SENDD presented information and next steps for the Planning Phase for the (CDBG). The presentation is attached to these minutes.

Both Jonathan and Tom expressed the importance of encouraging as many people as possible to participate in the planning process. This is exciting for the City of Milford.

Keib: Pool, Library, SSCSWMA, Cemetery.

<u>Freeman</u>: Recreation, Senior Center, Community Betterment, Webermeier Scholarships and Auditing.

Roth: Police, Fire, Water, Sewer and Auditing.

Appointments: A motion was made by DeLong and seconded by Freeman to accept the names presented as read: **Chief of Police** – Forrest Siebken; **City Clerk/Treasurer** – Jeanne Hoggins; **Maintenance Supt**. – Gary TeSelle; **Street Superintendent** – Julie Ogden with JEO from January 1 to December 31, 2021. Roll call vote: DeLong yes, Freeman yes, Keib yes, Roth yes. Motion carried.

Consider approval of Project #003 – Per Housing Committee Recommendation:

A motion was made by DeLong and seconded by Keib to approve Project #003 per the Housing Committee recommendation in the amount of \$24,925.00. Roll call vote: DeLong yes, Keib yes, Freeman yes, Roth yes. Motion carried.

Consider approval of Project #004 - Per Housing Committee Recommendation:

A motion was made by Keib and seconded by Freeman to approve Project #004 per the Housing Committee recommendation in the amount of \$12,580.00. Roll call vote: Keib yes, Freeman yes, DeLong yes, Roth yes. Motion carried.

Extend offer of employment for Police Dept and Set Wage:

Chief Siebken recommends hiring Austin Tucker as Police Officer. He is a Kansas certified officer with the Norton County Sheriff's Dept. He will need to attend 1 month of reciprocal training and has one year to complete this training.

A motion was made by DeLong and seconded by Freeman to extend an offer of employment to Austin Tucker with a starting wage of \$20.50, a .50 increase after 6 months and .50 increase at his anniversary date upon successful completion of background check and drug screening. Roll call vote: DeLong yes, Freeman yes, Keib yes, Roth yes. Motion carried.

Award bid for 2020 TCD Water Main Extension: A motion was made by DeLong and seconded by Roth to award the bid for the 2020 TCD Water Main Extension to Van Kirk

Bros. in the amount of \$61,380.00. Roll call vote: DeLong yes, Roth yes, Freeman yes, Keib yes. Motion carried.

Authorize Mayor Kelley to sign Audit Agreement with HBE CPA's & Consultants: Mayor Kelley explained that Marvin E. Jewell merged with HBE and the audit agreement presents similar to past audits. A motion was made by DeLong and seconded by Keib to authorize the Mayor to sign the Audit Agreement presented by HBE CPA's & Consultants. Roll call vote: DeLong yes, Keib yes, Freeman yes, Roth yes. Motion carried.

Authorize payment process for drawdown #2 for 19-TFHO-16065 Owner Occupied Rehab program. A motion was made by Freeman and seconded by DeLong to authorize payment for drawdown #2 as presented for 19-TFHO-16065 Owner Occupied Rehab program. Roll call vote: Freeman yes, DeLong yes, Keib yes, Roth yes. Motion carried.

ORDINANCE NO. 955

AN ORDINANCE OF THE CITY OF MILFORD, NEBRASKA AMENDING MILFORD MUNICIPAL CODE § 5-303 AS PROVIDED HEREIN REGARDING SPEED LIMITS.

WHEREAS, City Code § 5-303 provides for speed limits within the City;

WHEREAS, the City finds it expedient to amend portions of Code § 5-303 as provided herein.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MILFORD, SEWARD COUNTY, NEBRASKA AS FOLLOWS:

Section 1: That Milford Municipal Code § 5-303 (A)(1) be amended as follows:

No person shall operate a motor vehicle on any street at a rate of speed greater than is reasonable and prudent under the conditions then existing and except when a special hazard exists that requires lower speed, the limits specified in this paragraph or established as hereinafter authorized in this paragraph shall be maximum lawful speeds, and it shall be unlawful for the driver of any vehicle on any street within the City to drive such vehicle at a speed in excess of such maximum limits unless a different rate of speed is specifically permitted by ordinance or resolution:

- a. Fifteen (15) miles per hour in alley;
- b. Twenty (20) miles per hour within the business district;
- c. Fifteen (15) miles per hour on "D" Street from U.S. Highway 6 to Eighth (8th) Street from June 1 each year through November 1 of each year;
- d. Fifteen (15) miles per hour when flashing yellow lights are activated, 25 miles per hour when not flashing on First (1st) Street from "F" Street to Welch Park Road;
- e. Fifteen (15) miles per hour when flashing yellow lights are activated, twenty-five (25) miles per hour when not flashing on State Street from Highway 6 to the south City limits;
- f. Twenty-five (25) miles per hour on all other streets.
- g. Fifteen (15) miles per hour on Fairway Drive from U.S. Highway 6 to "D" Street from June 1 of each year through November 1 of each year.
- h. Fifteen (15) miles per hour on Eighth (8th) Street from D Street to B Street from June 1 through November 1 of each year.

Section 2: That all Ordinance and Code provisions or portions of such in conflict herewith are hereby repealed to that extent.

Section 3: That this Ordinance shall be in full force and effect from and after publication as provided by law, and shall be published in pamphlet form.
