Building Updates

February 8th, Councilwoman Freeman and Amy Salistean met with Councilman DeLong and Gary TeSelle about the responsibilities and expectations of the City of Milford Maintenance Department.

- Gary explained that currently, the Maintenance Department does not have any budget for maintaining City owned buildings or the properties around them.
 - o The Manager of the Senior Center is responsible for all maintenance contracting and then the cost will be entirely covered by the Senior Center.
