

SWIMMING POOL BOARD
MAY 1, 2024
MINUTES

The meeting was called to order at 7:00 pm by Leslie Toovey. Present: Chrystina Piening, Ashley Eicher, Leslie Toovey, Whitney Parks, and Council Liaison Becky Freeman. Absent: Chlancey Dittmer Also present: Maintenance Superintendent Gary Teselle, Roy Cast, Sharon Bender, Marian Eicher, Kari Jakub, Tiffany Reynolds and Kylie Kubicek.

The board would like to see an increase in the pool pass fee next year as well as consider increasing the suggested price for seniors to \$30 per single person and \$50 per couple.

A motion was made by Eicher and seconded by Parks to recommend having Kylie Kubicek, Kari Jakub and Tiffany Reynolds as pool operator and hiring of all applicants contingent upon their test and the pool board interview: Addyson Riley, Addison Sample (pool operator & guard), Sara Reynolds (pool operator & guard), Maeli Kubicek, Elizabeth Struwe (pool operator & guard), Harper McCullough, and Jackson Toovey & Hannah Reynolds as subs. Roll Call vote: Eicher yes, Parks yes, Piening yes, Toovey yes. Absent Dittmer. Motion carried.

A motion was made by Eicher and seconded by Parks to recommend wages be set by the pool board and the range be \$12.00 to \$20.00 per hour. And to increase the Senior suggested rate to \$30.00 per single person and \$50.00 per couple. Roll Call vote: Eicher yes, Parks yes, Piening yes, Toovey yes. Absent Dittmer. Motion carried.
