## CITY OF MILFORD PUBLIC HEARING TO EXCEED 1% SEPTEMBER 4, 2018 MINUTES

A regular meeting of the Mayor and Council of the City of Milford, Nebraska was held at the Milford Sr. Center in said City on the 4<sup>th</sup> day of September, 2018 at 7:00 o'clock p.m. for public hearing to allow the budget for fiscal year October 1, 2018 through September 30, 2019 to exceed 1%. Present: Mayor Nick Glanzer; Council members Jeff Baker, Scott Bashore, Patrick Kelley and Dan Kral; Attorney Krista Carlson; Chief of Police Forrest Siebken, Maintenance Supt. Gary TeSelle, Library Director George Matzen and City Clerk Jeanne Hoggins. Notice of the meeting was given in advance thereof by publishing in the Milford Times; a designated method for giving notice, as shown by the Affidavit of publication attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

**CALL TO ORDER:** Mayor Glanzer called the meeting to order at 7:00p.m. Mayor Glanzer publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act is available for review and is posted on the east wall of the Sr. Center.

**PUBLIC HEARING – EXCEED 1%:** Mayor Glanzer opened the Public Hearing at 7:00p.m., declared the purpose was to conduct a public hearing upon the proposal to exceed 1% on the 2018-2019 fiscal budget. This allows the City to increase restricted revenues including personal property taxes, local option sales tax, equalization, highway allocation, motor vehicle tax, etc... by 1%. The additional 1% equals about \$12,100.00. The unused restricted amount is about \$184,000.00. It is good to build the reserves incase anything would alter the local sales tax, highway allocation etc... There being no further comments Mayor Glanzer declared the Public Hearing closed at 7:04 p.m.

**ADJOURNMENT:** A motion was made by Bashore and seconded by Kral to adjourn the meeting. Roll call vote: Bashore yes, Kral yes, Baker yes, Kelley yes. Motion carried and meeting adjourned at 7:04 p.m.
