Marian also mentions that it was brought up with the JEO meeting that the city may add bump outs on 2 of the curbs, if that takes place that will also add a couple more spaces. Julie mentioned that we could also measure and repaint the current spaces, she said they are larger than what is actually required. Julie with JEO will be presenting to the city at their meeting.

Tony mentions that he feels we should cement the entire green space and be done with it. Why worry about a small green space? He goes on to say, keep it simple, maybe even have a drive way for pick ups and drop offs etc. Just cement the whole thing.
