# Milford Aging Service Commission of the City of Milford, Nebraska January 17, 2023

The open meeting was called to order by President Pat Grimes at 4:00pm. Roll call with the following present: Pat Grimes, Linda Nelson, Amy Salistean and Mike Moritz. Those absent were Ron Oswald, Diane Kemper, and Kelli Keib. Others present were: Susan Trabert, Kathy Ruzicka, and Arlene Moritz.

The Open Meeting Act Requirement was met.

December 20 2022 minutes were presented. Mike Moritz made a motion that the minutes be approved, second by Linda Nelson. Minutes were approved as presented.

### Managers' Report:
