Public notice is hereby given by the Mayor and City Council of the City of Milford, Nebraska, that two public hearings will be held at 7:00 p.m. on Tuesday, November 2, 2021, at the City Hall Office, 402 1st Street, Milford, Nebraska.

The purpose of each hearing is to obtain public comment prior to consideration of an amendment to the redevelopment plan of the City of Milford, which amendments shall each include a redevelopment project that will utilize tax increment financing.
