**Discuss Pool needs, equipment, etc.:** Discussion was held regarding items needed for the pool, they include: deck chairs, latches for gates, umbrellas (check height for guard stands). A motion was made by Maple and seconded by Jakub to purchase items needed for 2016 season. Roll call vote: Bontrager yes, Jakub yes, Maple yes, Taylor absent, Zegers absent. Motion carried.

Lindsey will schedule lessons around guard availability; she will let the Pool Board know dates.

Pool will open May 29 and close August 10, 2016.
