SWIMMING POOL BOARD SEPTEMBER 12, 2017 MINUTES

Discuss/Action – Operation procedures: Gary TeSelle presented the following information: A bid was received for hand dryers and installation (?), stabilizers in pool allowed less chlorine to be used due to better chemical checks, things were handled very well. \$7289.52 savings in operation expenses compared to 2016. There was also an increase in revenue by \$1,504.03.

7. Discuss/Action - New Diving Board: JEO quoted approximately \$20,000.00 to replace the current board.

8. Discuss/Action – Climbing Wall: Different types of climbing walls were discussed. Previous quote was \$50,000.00, Lori received quote of around \$10,000.00.

9. Discuss/action – Pool House Renovations: Waiting on estimates.

Chairman Craig Bontrager excused himself from the rest of the meeting.

Discuss/Action – Addition /Changes to Pool Manual: Lori Johnson presented a list of recommendations for the 2018 Pool Season. The Board reviewed the document and it is attached to these minutes. Highlighted areas have been considered as changes to the Pool Manual. A motion was made by Jakub and second by Toovey to approve the changes and additions to the Manual. Roll call vote: Jakub yes, Toovey yes, Taylor yes, Zegers yes. Motion carried.
