RECREATION BOARD OCTOBER 30, 2013 MINUTES

APPROVE MINUTES:

HIRE CO-ED VOLLEYBALL DIRECTOR: Motion to hire Bruce Stutzman as the Co-Ed Volleyball Director was made by T. McCall and seconded by J. Roth. Motion carried 6-0.

HIRE YOUTH BASKETBALL DIRECTOR: There were no applications submitted for this position so suggestion was made to ask the Junior and Senior High Basketball players to oversee this skills camp. Each individual would be paid \$8.00/hr. If multiple applications are submitted a sub group of 3 Recreation Board members will be created to interview the applicants. Motion made by T. McCall and seconded by B. Wingard to put announcement at High School to ask for helpers to coach/help coach youth. (See attached) Motion carried 6-0.

DISCUSS/ACTION SPORTS EXPRESS FIELD USAGE: Idea discussed to waive field rental fee for Sports Express to use all 3 fields on Wednesday nights for a six week period if they were to operate the concession stand. Proposal will be made to Sports Express that they would meet a minimum concession stand income at the end of the six week period. That amount will be determined at the next Rec Board Meeting. This proposal will be presented to Marty Rowland by Councilman Baker. Item tabled.

UPDATE ON OUTFIELD SIGNS: Chamber brought in \$470 profit for the outfield fence signs. City was given \$47 for our share of profit.

McCall stated that we need to look into new electronic controllers for scoreboards as High School had trouble with them at Districts

DISCUSS/ACTION BACKGROUND CHECKS FOR COACHES: Rec Board is requesting Chief Siebken to come talk to them about background checks.

ADJOURNMENT: A motion was made by T. McCall and seconded by J. Roth to adjourn. Motion carried 6-0. Meeting adjourned at 8:25 p.m.
