A special meeting of the Mayor and Council of the City of Milford, Nebraska was held at the City Hall Office in said City on the 9<sup>th</sup> day of April, 1999 at 5:00 P.M. Present were: Mayor Dean Bruha; Councilmembers Dorothy Bockoven, Scott Burroughs, Gary Cooper; Deputy City Clerk Jeanne Hoggins. Absent: Rick Fortune.

Notice of the meeting was given in advance thereof by posting in three public places; a designated method for giving notice, as shown by the Certification of posting attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

**CALL TO ORDER:** The meeting was called to order by Mayor Bruha at 5:07 P.M.

**NEW BUSINESS:** Bruha introduced the Interlocal Cooperation Act Agreement as a proposal for housing funds for Seward County. Funds would be distributed by the City of Seward for the purchase of older homes or for construction of new homes for first time home buyers. Burroughs asked about the financial constraints. Bruha was not sure of dollar figure for homes but estimated homes to run around \$70,000. This did not include lot costs. Bruha advised council that no tax money would be needed to participate in the program. A motion was made by Bockoven and seconded by Burroughs to authorize Mayor to sign Interlocal Cooperation Act Agreement. Roll call vote: Bockoven yes, Burroughs yes, Cooper yes. Motion carried.

**ADJOURNMENT:** A motion was made by Bockoven and seconded by Cooper to adjourn the meeting. Roll call vote: Bockoven yes, Cooper yes, Burroughs yes. Motion carried and meeting adjourned at 5:14 P.M.
