## CITY OF MILFORD SPECIAL MEETING JULY 24, 2002 MINUTES

A special meeting of the Mayor and City Council of the City of Milford, Nebraska was held at the Webermeier Community Room, in said City on the 24<sup>th</sup> day of July 2002 at 6:00 pm. Absent: Attorney Robert Blevens.

Notice of the meeting was given in advance thereof by posting in three public places; a designated method for giving notice, as shown by the Certification of posting attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Lyle Neal presented a summary of payroll increases from 3% to 5%. After the Council reviewed the summary a motion was made by Neal and seconded by Fortune to increase wages 3% per the calculation sheet, which was provided, with no increase for the two new officers. Roll call vote: Neal yes, Fortune yes, Burroughs yes, Cooper yes. Motion carried.

**Budget Preparation:** Mayor and Council reviewed the budget line by line. Final figures will be added by Hoggins and submitted the Accountant Dennis Kubicek.

**ADJOURNMENT:** A motion was made by Burroughs and seconded by Cooper to adjourn the meeting. Roll call vote: Burroughs yes, Cooper yes, Fortune yes, Neal yes. Motion carried and meeting adjourned at 8:21 pm.
