## CITY OF MILFORD SPECIAL MEETING MARCH 13, 2014

A special meeting of the Mayor and City Council of the City of Milford, Nebraska was held at the City Hall Office, 505 1<sup>st</sup> Street in said City on the 13<sup>th</sup> day of March 2014 at 5:00 pm. Present were: Mayor Dean Bruha; Council members: Jeff Baker, Rick Fortune, Dan Kral; Chief of Police Forrest Siebken and City Clerk Jeanne Hoggins. Absent: Council member Jeff Heckman.

Notice of the meeting was given in advance thereof by posting in three public places; a designated method for giving notice, as shown by the Certification of Posting attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

**CALL TO ORDER:** Mayor Bruha called the meeting to order at 5:05 pm. Mayor Bruha publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act is available for review and is posted on the south wall of the meeting room at the City Office.

Hire Police Officer and set wage: Chief Siebken provided the resume of Scott W. McNeil and briefed the Council regarding his experience. With his military experience he will be able to work on his own prior to attending the police academy. In August he will attend the Nebraska Law Enforcement Training Center in Grand Island for officer certification. Prior to attending the Nebraska Law Enforcement Training Center, he will be required to sign a "Promissory Note" for the costs of wages and insurance while in attendance. 25% of those costs will be forgiven with each successful year of employment. With that, Chief Siebken recommended hiring Scott W. McNeil as a police officer at a starting wage of \$17.06 per hour or \$35,500.00 annually. Upon his graduation from the Academy an increase in salary to \$17.30 per hour or \$36,000.00 annually will occur. A motion was made by Kral and seconded by Fortune to hire Scott W. McNeil at a beginning salary of \$17.06 per hour with an increase to \$17.30 per hour at the successful completion of the Police Academy. Roll call vote: Kral yes, Fortune yes, Baker yes, Heckman absent. Motion carried.

**ADJOURNMENT:** A motion was made by Fortune and seconded by Kral to adjourn the meeting. Roll call vote: Fortune yes, Kral yes, Baker yes, Heckman absent. Motion carried and meeting adjourned at 5:13 pm.
