- Six area pastors and 3 of their wives made reservations for Pastor's Appreciation Day, to be held September 29, 2010.

- On October 13<sup>th</sup>, the Center will be host to "Yesterday's Lady", a program on a Victorian Christmas. It will be a dessert luncheon: cost will be \$5.00. Details need to be worked out.
- Gwen reported that on November 3 we will have a special music program for noon meal. More information will be available later.
- Willis opened the bids for noon meals for next year, beginning in October. Crestview: did not bid Sunrise: their bid is \$4.75 per meal. Kathy suggested we charge \$4.25 per meal with the balance coming from the USDA. Vera made a motion to charge \$4.25 per person, Gwen seconded it. Motion carried. Doris made a motion to take the balance between the \$4.25 and the \$4.75 out of funds from USDA. Vera seconded it. Motion carried.
