# Consider SCCDP Funding Agreement request for 2024-2025.

Consider SCCDP Annual Membership Agreement for 2024-2025.

Jonathan Jank and Vice Chair Scott Giehran presented on behalf of SCCDP. Jonathan

thanked the City of Milford for their investment in the organization and partnership with SCCDP. A special thank you to Mayor Kelley as an active board member serving as Board Chair. The 2023 Funding Agreement dated 10/1/23 thru 9/30/24 shows the city's investment of \$12,566.00 and is spent for the operations of the organization. Public funds are tracked in a separate account, and they are mindful of this as they do the financial reviews each year. The private sector fundraising and membership drive was completed by the end of the year. Job performance evaluations, audit and external financial reviews

were all performed to meet compliance with the agreement. Jonathan is asking the governing body to consider entering into the new Membership Agreement and Funding Agreement for the 24-25 fiscal year. Jonathan highlighted some of the Economic and Community Development efforts from over the past 12 months. (Document attached)

Scott Giehran from Utica is on the SCCDP Board of Directors. Scott shared his experiences working with SCCDP as they help and guide multiple organizations in Utica and throughout Seward County.

Jonathan noted the increase in funding request of 6% comes from the need to keep talented staff, provide insurance for the first time and pay rent at the Civic Center of over \$10,000.00 per year. Other county members are being asked for 6% also.

Mayor Kelley encouraged the council to approve the funding request of \$13,320.00 to assist SCCDP with their growing needs.

A motion was made by DeLong and seconded by Freeman to approve the SCCDP Funding Agreement request and the Annual Membership Agreement for 2024-2025 including the 6% increase in the amount of \$13,320.00 from 10/1/24 through 9/30/25. Roll call vote: DeLong yes, Freeman yes, Keib absent, Roth yes. Motion carried.
