CITY OF MILFORD SPECIAL MEETING APRIL 20, 2021

A special meeting of the Mayor and City Council of the City of Milford, Nebraska was held at the City Hall Office, 402 1st Street in said City on the 20th day of April 2021 at 6:30 pm. Present were: Mayor Patrick Kelley; Council members: Tony DeLong, Becky Freeman, Mike Roth and City Clerk Jeanne Hoggins. Absent: Council member Kelli Keib.

Notice of the meeting was given in advance thereof by posting in three public places; a designated method for giving notice, as shown by the Certification of Posting attached to these minutes. Notice of this meeting was given to the Mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

CALL TO ORDER: Mayor Kelley called the meeting to order at 6:32 pm. Mayor Kelley publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act is available for review and is posted on the west wall of the City Hall meeting room.

Authorize final payment of \$17,594.90 to Tru-Built Construction on the new City Hall Office/Police Station @ 402 1st Street: Mayor Kelley noted, he had been holding payment back due to the issues related to the HVAC system. There was a loud fan noise in the large meeting room which was fixed by modification to duct work. Code regulations allow a 4-degree minimum swing in temperature settings. We are experiencing temperature swings within the building of a 10-degree difference. Trend meters have been left in the building to monitor temperatures.

Hoggins added a 2-degree rise in temperature seems extremely hot, likewise the 2-degree temperature decrease seems very cold. The happy medium never seems to last long. There is also a cool/cold breeze that dumps down on top of the ladies at the front counter.

Mayor Kelley had email conversations with Steve to work with subs to make the building more comfortable. They have known about this concern since we moved in. He even had conversation with Mike Roth who teaches and specializes in HVAC to see what could be done.

We are past our year mark and Tru-Built is pushing for final payment.

Hoggins noted that Ron Feuerbach with Morrissey Engineering and Rob Hemmer with Mechanical Sales are coming out on Thursday to revisit our concern.

A motion was made by DeLong and seconded by Freeman to authorize final payment to Tru-Built Construction in the amount of \$17,594.90 for construction work on the new municipal building. Roll call vote: DeLong yes, Freeman yes, Keib absent, Roth yes. Motion carried.

ADJOURNMENT: A motion was made by Freeman and seconded by Roth to adjourn the meeting. Roll call vote: Freeman yes, Roth yes, DeLong yes, Keib absent. Motion carried and meeting adjourned at 6:49 pm.


