CITY OF MILFORD SPECIAL MEETING FEBRUARY 15, 2023 MINUTES

A special meeting of the Mayor and Council of the City of Milford, Nebraska was held at the City Hall Building in said City on the 15th day of February 2023 at 7:00 pm. Present were Mayor Patrick Kelley; Council members: Tony DeLong, Becky Freeman, Kelli Keib, Mike Roth; Attorney Anthony Aerts and City Clerk Jeanne Hoggins. Also present: Rod Schildt, Todd Vegas and Emily Hemphill.

Notice of the meeting was given in advance thereof by publishing in the Milford Times a designated method for giving notice, as shown by the Affidavit of Publication attached to these minutes. Notice of the meeting was given to the mayor and all members of the Council and a copy of their acknowledgement of receipt of notice and the agenda is attached to these minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

CALL TO ORDER: Mayor Kelley called the meeting to order at 7:00 pm. and publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act is available for review and is posted on the west wall in the City Hall meeting room.

PLEDGE OF ALLEGIANCE:

APPROVE AGENDA AS SUBMITTED: A motion was made by Freeman and seconded by DeLong to approve the agenda as submitted. Roll call vote: Freeman yes, DeLong yes, Keib yes, Roth yes. Motion carried.

CONSENT AGENDA: Mayor Kelley read the Consent Agenda:

A motion was made by DeLong and seconded by Roth to approve items on the consent agenda as read. Roll call vote: DeLong yes, Roth yes, Freeman yes, Keib yes. Motion carried.

PUBLIC HEARINGS:

Public Hearing to hear testimony in favor of, or opposition to, and to answer questions in relation to a proposed Conditional Use Permit located at 521 First Street, Schildt Addition Lot 1, to place a storage shed at the rear of the property.

Mayor Kelley opened the public hearing at 7:04 pm. Rod Schildt noted they had a storage unit rented that was inaccessible, too small and inconvenient. They decided to look into this storage unit which has double doors, ground level and close to the office. The Planning Commission held a meeting Monday evening and are making a recommendation to approve the conditional use permit as submitted. With no further questions, Mayor Kelley closed the public hearing at 7:06 pm.

Mayor Kelley opened the public hearing at 7:06 pm. Owner of the Uptown Tavern, Todd Vegas noted not much to discuss. Mayor Kelley mentioned that changes should be made to the C-1 Zoning District to include restaurants/bars under the permitted uses. Discussion was held regarding the outside cooler being enclosed per building requirements. With no further comments, Mayor Kelley closed the public hearing at 7:11 pm.

Mayor Kelley opened the public hearing at 7:11 pm. No initial questions or comments were asked. Clerk Hoggins asked about the machine type games. Todd Vegas stated they are already permitted to have those and they are considered "games of skill". Mayor Kelley commented that this will be a great benefit to the community. A RESOLUTION TO ADOPT A POLICY OPPOSING DISCRIMINATION IN THE ACQUISITION, OWNERSHIP, POSSESSION OR ENJOYMENT OF HOUSING; TO ASSIST AGGRIEVED PERSONS IN FILING COMPLAINTS BY PROVIDING CERTAIN INFORMATION.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MILFORD, NEBRASKA, THAT;

- 1. It shall be the policy of the Governing Body to oppose discriminating practices on the basis of race, color, religion, national origin, handicap, familial status or sex in the acquisition, ownership, possession or enjoyment of housing in accordance with the Nebraska State Fair Housing Act and Article 1, Section 25 of the Constitution of the State of Nebraska; and
- It shall be the policy of the Governing Body to assist aggrieved persons in filing complaints in regards to discriminatory housing practices by providing information on the Nebraska Fair Housing Act and the Nebraska Equal Opportunity Commission.

RESOLUTION NO. 648

A RESOLUTION OF THE CITY OF MILFORD, NEBRASKA, APPROVING THE EXPENDITURE OF PUBLIC FUNDS FOR NONALCOHOLIC BEVERAGES AND MEALS FOR AN ANNUAL RECOGNITION EVENT ACKNOWLEDGING THE RETIREMENT AND YEARS OF SERVICES OF THE CHIEF OF POLICE, AND ESTABLISHING THE MAXIMUM COST PER ATTENDEE AT SUCH RECOGNITION EVENT.

WHEREAS, for a period of 38 years, Forest K. Siebken ("Siebken"), the Chief of Police of the City of Milford, Nebraska (the "City"), has provided diligent, devoted, and the highest quality of service to the City; and

WHEREAS, at a public meeting of the City Council on December 6, 2022, Siebken announced that he will be retiring from service to the City, effective April 21, 2023; and

WHEREAS, the City wishes to organize and hold an event open to the general public recognizing Siebken's retirement and years of service to the City; and

WHEREAS, Neb. Rev. Stat. § 13-2202 permits the governing body of municipalities to take formal action to approve the expenditure of public funds on nonalcoholic beverages and meals for one recognition event each year for each elected or appointed official of said municipality in an amount not to exceed fifty dollars per attendee at such event.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MILFORD, NEBRASKA, that the City of Milford hereby agrees and resolves as follows:

- 1. A recognition event in honor of Siebken's retirement and years of service to the City shall be organized and hosted by the City on a date in 2023 to be mutually determined by the Mayor and Siebken, and such recognition event shall be made open to the general public.
- 2. The City hereby approves and authorizes the expenditure of public funds to purchase nonalcoholic beverages and meal and / or food items for such recognition event in an amount not to exceed \$50.00 per attendee at such event, or \$500.00 in total.
